I am directed to refer to the Ministry of Coal's letter no. 13016/38/2015-CA-III dated 18.09.2015 on the above subject requesting this Ministry's to transfer its approval granted under the Forest (Conservation) Act, 1980 for diversion of forest land for coal mining at Manoharpur and Dipside Manoharpur coal block in Sundergarh District in the State of Odisha from the original user agencies i.e. M/s Odisha Power Generation Corporation Limited in whose favour forest land was diverted to new user agency i.e. M/s Odisha Coal and Power Limited in whose favour the coal block was re-allotted by the Ministry of Coal, in accordance with para 2.8 of the Guidelines issued under the Forest (Conservation) Act, 1980 read with the Guidelines dated 3.05.2010, 3.05.2013 and latest Guidelines dated 31.03.2015.

In this connection. I am directed to refer to the State Government of Odisha's letter No. 10F (Cons.)-581/2011-10568/F & E dated 08.06.2011 on the above mentioned subject, wherein prior approval of the Central Government for the diversion of 200.465 hectares of forest land including 4.42 hectares for safety zone in Manoharpur Coal Block of IB-Valley Coalfields in Sundergarh district of Orissa by M/s Orissa Power Generation Corp. Ltd was sought, in accordance with Section-2 of the Forest (Conservation) Act, 1980. Later on the Regional Office, Eastern Zone, Bhubaneshwar of this Ministry after inspection of the said forest land inter-alia informed this Ministry that in addition to the recorded forest area, a few adjoining patches of the Govt. revenue land having cumulative area of 76.19 hectare having a recorded status of non-forest is also having natural tree growth including Sal and its associate species, qualifying to be reckoned as "forest". After careful consideration of the proposal by the Forest Advisory Committee constituted by the Central Government under section 3 of the said Act, in-principle approval for the said diversion was granted vide this Ministry's letter of even number dated 17th October 2012, subject to fulfillment of certain conditions. The State Government has furnished compliance report in respect of the conditions stipulated in the in-principle approval and has requested the Central Government to grant final approval.

- (i) Legal status of the diverted forest land shall remain unchanged;
- (ii) Compensatory afforestation over the non-forest land equal in extent to the 276.655 hectares of forest land (including the said 76.19 hectares area which is to be treated as "Forest" as per dictionary meaning) transferred and mutated in favour of the State Forest Department shall be raised and maintained by the State Forest Department from funds realised from the user agency;

- (ix) State Government shall undertake afforestation on degraded forest land, one and half time in extent to the area used for safety zone from funds already realised from the user agency;
- (x) Period of diversion of the said forest land under this approval shall be for a period co-terminus with the period of the mining lease proposed to be granted under the Mines and Minerals (Development & Regulation) Act, 1957, or Rules framed there under, subject to a maximum period of 30 years;
- (xi) User agency shall undertake gap planting and soil & moisture conservation activities to restock and rejuvenate the degraded open forests (having crown density less than 0.4), if any, located in the area within 100 m. from outer perimeter of the mining lease as per the plan technically approved by Regional Chief Conservator of Forests, Rourkela Circle;
- (xii) User agency shall undertake de-silting of the village tanks and other water bodies located within five km from the mine lease boundary so as to mitigate the impact of siltation of such tanks/water bodies, whenever required as per the plan technically approved by Regional Chief Conservator of Forests, Rourkela Circle;
- (xiii) The User Agency shall undertake mining in a phased manner after taking due care for reclamation of the mined over area. The concurrent reclamation plan shall be executed by the User Agency from the very first year, and an annual report on implementation thereof shall be submitted to the Nodal Officer, Forest (Conservation) Act, 1980, Government of Odisha and the Addl. 

I am directed to refer to the Government of Odisha's letter No.10F (Cons) 112/19-25139/F&E, Bhubaneswar, dated 21.12.19 on the above subject seeking prior approval of the Central Government under Section 2 of the Forest (Conservation) Act, 1980 and subsequent letter dated 14.12.2020 and 11.08.2021 forwarding additional information as sought by the Ministry's vide its letters of even numbers dated 31.01.2020 and 1.03.2021, respectively and to say that the proposal has been examined by the Forest Advisory Committee constituted by the Central Government under Section-3 of the aforesaid Act.

After careful examination of the proposal of the State Government and on the basis of the recommendations of the Forest Advisory Committee, and approval of the same by the competent authority of the MoEF&CC, New Delhi, the Central Government hereby accords 'in-principle' approval under Section - 2 of the Forest (Conservation) Act, 1980 for non-forestry use of 15.701 ha of revenue forest land in the villages of Dulanga, Ghumudasan and Manoharpur under Hemgiri Tahasil of Sundargarh district for Coal Mining in Manoharpur Coal Mine Project by M/s Odisha Coal and Power Ltd. (OCPL) under DFO, Sundargarh subject to fulfilment of the following conditions:

- A. Conditions that need to be complied prior to handing over of forest land by the State Forest Department and compliance is to be submitted prior to Stage-II approval
- 1. Compensatory Afforestation (CA):
- i. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and the cost of survey, demarcation and erection of permanent pillars, if required on the CA land, shall be deposited in advance with the Forest Department by the user agency. The CA will be maintained for 10 years. The scheme may include afforestation of indigenous species with appropriate provision for anticipated cost increase for works scheduled for subsequent years;



- ii. The non-forest land identified for CA shall be transferred and mutated in favour of the State Forest Department and subsequently notified by the State Government as RF under Section 4 or PF under Section-29 of the Indian Forest Act, 1927 or under the relevant Section(s) of the local Forest Act before Stage-II approval. A copy of the final Notification shall be submitted along with the compliance of Stage-I approval; and
- iii. The KML files of diverted area, the CA areas, the proposed SMC treatment area and the WLMP area shall be uploaded on the e-Green watch portal with all requisite details prior to Stage II approval.
- 2. State Government shall ensure that the CA area earmarked against earlier diversions of forest land under the provisions of FCA 1980 is mutated and notified as RF/PF as per the provisions of law. The compliance shall be

submitted prior to Stage II approval;

- 3. The User Agency shall transfer the funds towards the cost of Net Present Value (NPV) of the forest land being diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 28.03.2008, 24.04.2008 and 09.05.2008 in Writ Petition (Civil) No. 202/1995 and the guidelines issued by this Ministry vide its letter No. 5-3/2007-FC dated 05.02.2009 through online portal of CAMPA account of the State Concerned:
- 4. Compensatory levies to be realized from the User Agency under the project shall be transferred/ deposited, through e-challan, into the account of CAMPA pertaining to the State concerned through e-portal (https://parivesh.nic.in/);
- 5. In consultation with the State Forest Department, following schemes/plans shall be prepared and implemented by the user agency in consultation with the State Forest Department and copies of the same will be submitted to the Ministry along with Stage-I compliance:
- i. Mitigative measures to minimize soil erosion and choking of stream, to be implemented within a period of three year of issue of Stage-II approval.
- ii. For planting of adequate drought hardy plant species and sowing of seeds, in the appropriate area within the mining lease to arrest soil erosion:
- iii. For construction of check dams, retention /toe walls to arrest sliding down of the excavated material along the contour
- iv. To stabilize the overburden dumps by appropriate grading/ benching, which should also ensure angles of repose at any given place is less than 28°; and

v. Top soil management plan.

- 6. The User Agency shall prepare a list of existing village tanks and other water bodies with GPS co-ordinates located within five km from the mine lease boundary. This list is to be duly verified by the concerned Divisional Forest Officer. The User Agency shall regularly undertake desilting of these village tanks and other water bodies so as to mitigate the impact of siltation of such tanks/water bodies. A detailed approved plan for desilting of identified ponds and water bodies to be prepared in consultation with forest department and shall be submitted to MoEF & CC:
- 7. The cost of felling of trees shall be deposited by the User Agency with the State Forest Department;
- 8. State government shall submit a certificate that no plantation activities has been taken by the Forest department under any scheme/plan/programme in the land proposed for CA in last 10 years.



9. State Government shall complete settlement of rights, in term of the Scheduled Tribes and Traditional Forest Dwellers (Recognition of Forest Rights) Act. 2006, if any, on the forest land to be diverted and submit the documentary evidence, as prescribed by this Ministry's letter No. 11-9/1998-FC (Pt.) dated 03.08.2009 read with 05.07.2013, in support thereof; and

compliance report shall be uploaded on e-portal (https://

parivesh.nic.in/).

B. Conditions which need to be complied on field after handing over of forest land to the user agency by the State Forest Department and undertaking in this respect shall be submitted prior to Stage-II

1. Legal status of the diverted forest land shall remain unchanged:

2. The compensatory afforestation over non-forest land, equal in extent to the forest land being diverted shall be raised by the State Forest Department at the project cost. The State Government shall ensure that compensatory afforestation over the non-forest land equal in extent to the forest land being diverted shall be raised within three years from the date of issue of Stage -II Clearance and maintained thereafter as per approved plan by the State Forest Department at the cost of the User Agency:

3. At the time of payment of the NPV at the present rate, the user agency shall furnish an undertaking to pay the additional amount of NPV, if so determined,

as per the final decision of the Hon'ble Supreme Court of India;

4. Trees should be felled in phased manner as per the requirement in the approved Mining Plan with prior permission of concerned DFO;

5. The user agency shall explore the possibility of translocation of maximum number of trees identified to be felled and shall ensure that any tree felling shall be done only when it is unavoidable and that too under the supervision of

the State Forest Department.

- 6. The User Agency shall undertake mining in a phased manner after taking due care for reclamation of the mined over area. The concurrent reclamation as per the approved mining plan shall be executed by the User Agency from the very first year, and an annual report on implementation thereof shall be submitted to the Nodal Officer, Forest (Conservation) Act, 1980, in the concerned State Government and to the concerned Regional Office of the Ministry. If it is found from the annual report that the activities indicated in the concurrent reclamation plan are not being executed by the User Agency, the Nodal Officer or the concern Regional Officer of MoEF&CC may direct for suspension of mining activities till such time such reclamation is satisfactorily executed.
- 7. The State Government and the user agency shall ensure that safety zone is maintained as per the prescribed norms. The following activities shall be undertaken by the user agency for the management of safety zone:
- User agency shall ensure demarcation of boundary of safety zone (7.5 meter strip all along the inner boundary of the mining lease area), and its protection by erecting adequate number of 6 feet high RCC boundary pillars inscribed with DGPS coordinates with barbed wire fencing and deploying adequate number of watchers under the supervision of the. State Forest Department;

ii. Boundary of the safety zone of the mining lease, adjacent to habitation/roads,

should be properly fenced by the user agency:

iii. Safety zone shall be maintained as green belt around mining lease and to ensure dense canopy in the area, regeneration shall be taken up in this area by the user agency at project cost under the supervision of the State Forest

iv. The State Government and the user agency shall ensure that safety zone is maintained as per the prescribed norms;

v. The State Govt. and the user agency shall ensure that no mining shall be carried out in the land required to be maintained as safety zone all around the

mining area;

vi. Afforestation on degraded forest land to be selected elsewhere, measuring one and a half times the area under safety zone, shall also be done at the project cost under the supervisions of the State Forest Department. Afforestation will be done within three years from the date of Stage-II clearance and maintained thereafter in accordance with the approved Plan in consultation with the State Forest Department;

8. The User Agency shall comply with the Hon'ble Supreme Court order on regrassing, and re-grass the mining area and any other areas which may have been disturbed due to mining to restore them to a condition which is fit for

growth of fodder, flora, fauna, etc. in a timely manner;

9. Period of diversion of the said forest land under this approval shall be for a period co-terminus with the period of the mining lease proposed to be granted under the Mines and Minerals (Development and Regulation) Act, 1957, as amended and the Rules framed there-under;

10. The User Agency shall obtain the Environment Clearance as per the

provisions of the Environmental (Protection) Act, 1986, if required;

11. No labour camp shall be established on the forest land and the User Agency shall provide fuels preferably alternate fuels to the labourers and the staff working at the site so as to avoid any damage and pressure on the nearby forest areas;

12.The boundary of the diverted forest land, mining lease and safety zone, as applicable, shall be demarcated on ground at the project cost, by erecting four feet high reinforced cement concrete pillars, each inscribed with its serial

number, distance from pillar to pillar and DGPS coordinates;

13. The layout plan of the mining plan/ proposal shall not be changed without the prior approval of the Central Government and the forest land shall not be used for any purpose other than that specified in the proposal;

14. The forest land proposed to be diverted shall under no circumstances be transferred to any other agency, department or person without prior approval of the Central Government:

15. No damage to the flora and fauna of the adjoining area shall be caused;

16. The User Agency shall submit the annual self-compliance report in respect of the above stated conditions to the State Government, concerned Regional Office and to this Ministry by the end of March every year;

17. Any other condition that the concerned Regional Office of this Ministry may stipulate with the approval of competent authority in the interest of

conservation, protection and development of forests & wildlife; and

18. The user agency shall comply all the provisions of the all Acts, Rules, Regulations, Guidelines, Hon'ble Court Order (s) and NGT Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.

19. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would be taken as prescribed in para 1.21 of Chapter 1 of the Handbook of comprehensive guidelines of Forest (Conservation) Act, 1980 as issued by this Ministry's letter No. 5-2/2017-FC

I am directed to refer to the State Government of Odisha's letter No 10F (Cons) 522/2012-21413 /F & E dated 17th November 2012 on the above mentioned subject, wherein prior approval of the Central Government for the diversion of 159.616 hectares of forest land for Railway siding of Merry-Go-Round (MGR System) in Sundergarh and Jharsuguda districts by M/s. Odisha Power Generation Corporation Ltd, was sought, in accordance with Section 2 of the Forest (Conservation) Act, 1980. After careful consideration of the proposal by the Forest Advisory Committee constituted by the Central Government under Section-3 of the said Act, in-psinciple approval for the said diversion was granted vide this Ministry's letter of even number dated 10th September 2013, subject to fulfillment of certain conditions. The State Government has furnished compliance report in respect of the conditions stipulated in the in-principle approval and has requested the Central Government to grant final approval.

- 2. In this connection, I am directed to say that on the basis of the compliance report furnished by the Government of Odisha vide their letter No. 16F (Cons)-522/ 2012-20971/ F & E dated 17th November 2014, approval of the Central Government is hereby granted under Section-2 of the Porest (Conservation) Act, 1980 for diversion of 159.616 bectares of forest land for Railway siding of Merry-Go-Round (MGR System) in Sundergarh and Pharsuguda districts by M/s. Odisha Power Generation Corporation Ltd. subject to fulfillment of the following conditions:
- (i) Legal status of the diverted forest land shall remain unchanged;
- (ii) State Government shall create and maintain from funds realised from the user agency the compensatory afforestation over non-forest land equal in extent to the forest land being diverted transferred and mutated in favour of the Stat e Forest Department;

- (iii) Non-forest land which is transferred and mutated in favour of the State Forest Department for the purpose of compensatory afforestation, shall be declared as Reserved Forest under Section-4 or Protected Forest under Section-29 of the Indian Forest Act, 1927 or under the relevant Section(s) of the local Forest Act. Nodal Officer, Forest (Conservation) Act, 1980, Government of Odisha shall report compliance within six months;
- (iv) State Government shall realize from the user agency the additional NPV, if so determined, as per the final decision of the Hon'ble Supreme Court of India and transfer the same to the Ad-hoc CAMPA under intimation to this Ministry;
- The user agency shall obtain the Environment clearance as per the provisions of the Environmental (Protection) Act, 1986; if required;
- (vi) No labour camp shall be established on the forest land;
- (vii) Felling of trees on the forest land being diverted shall be reduced to the bare minimum and the trees should be felled under strict supervision of the State Forest Department;
- (viii) The user agency shall undertake afforestation along both sides of the Railways line;
- (ix) The user agency shall provide free water for the forestry related projects:
- (x) The user construct underpasses of minimum six meter height and minimum six meter width at 30 locations identified by the user agency in consultation with the Divisional forest Officer-cum-Chief Wildlife Warden, Sundergarh;
- (xi) The user agency shall restrict the speed of train at vulnerable location failing on migratory corridor/ path for elephants and other wild animals;
- (xii) The State Potest Department shall deploy from funds provided by the user agency the adequate number of watchers equipped with appropriate communication equipment along the railway line to detect and warn the train driver about movement of animals;
- (xiii) The user agency shall deploy adequate number of watchers equipped with binoculars and search lights in driver cabin of each train running on the said line as per the scheme technically approved by the Regional Chief Conservator of Porests, Rourkela, to detect the presence of elephants/ wild animals to alert the driver to stop the train. These watchers would be under the supervision and control of the wildlife wing in the State Forest Department and their payment would be met by the user agency;
- (xiv) The user agency shall create and maintain alternate habitat/ home for the avifauna, whose nesting trees are to be cleared in this project as per the scheme technically approved by the Regional Chief Conservator of Forests, Rourkela. Bird nests artificially made out of eco-friendly materials shall be used in the area, including forest area and human settlements, adjoining the forest area being diverted for the project;

- (xv) The State Government of Odisha and the user agency shall undertake Rehabilitation and Resettlement (R & R) of the project affected families, in a time bound and transparent manner;
- (xvi) Sufficient firewood or any other alternate fuel for cooking etc. shall be provided by the User Agency to the labourers after purchasing the same from the State Forest Department or the State Forest Development Agency or any other source of the alternate fuel;
- (xvii) The forest land being diverted for execution of the project shall be demarcated on ground at the project cost, by using four feet high RCC pillars, each pillar inscribed with the serial number, DGPS coordinates, forward and backward bearings and distance from the adjoining pillars etc.;
- (xviii) The forest land shall not be used for any purpose other than that specified in the proposal;
- (xix) In no circumstances the forest land proposed to be diverted in favour of any other user agency without obtaining prior approval of Central Government under the Forest (Conservation) Act, 1980;
- (xx) User agency shall submit annual report on compliance to conditions stipulated in this approval to the State Government and concerned Regional Office of this Ministry; and
- (xxi) Any other condition that the Regional Office (Eastern Zone), Bhubaneswar may impose from time to time for protection and improvement of flora and fauna in the forest area.



- (1) the Government Company shall make all payments in respect of compensation, interest, damages, etc., and the like, as determined under the provisions of the said Act and other relevant laws;
- (2) a Tribunal shall be constituted under section 14 of the said Act, for the purpose of determining the amounts payable by the Government Company under condition (1) and all expenditure incurred in connection with any such Tribunal and persons appointed to assist the Tribunal shall be borne by the



Government Company and similarly, all expenditure incurred in respect of all legal proceedings like appeals, etc., for or in connection with the rights, in or over the said land, so vesting, shall also be borne by the Government Company;

- (3) the Government Company shall indemnify the Central Government or its officials against any other expenditure that may be necessary in connection with any proceedings by or against the Central Government or its officials, regarding the rights in or over the said lands so vested;
- (4) the Government Company shall have no power to transfer the said lands to any other persons without the prior approval of the Central Government; and
- (5) the Government Company shall abide by such directions and conditions as may be given or imposed by the Central Government for particular areas of the said lands as and when necessary.

In inviting reference to the subject and letter cited above, I am directed to say that Government in Water Resources Department have been pleased to issuance of NOC in favour of M/s Odisha Coal and Power Limited (OCPL) for diversion of Garia Nallah and Lapani Nallah passing through dip side Manoharpur Coal Block in Sundargarh District with the terms and conditions mentioned below:-


Terms and Conditions:-

- OCPL shall divert the Garia Nallah & Lapani Nallah in accordance with the provisions made in the mining plan of Dipside Manoharpur coal block which has been approved by Ministry of Coal, Government of India.
- OCPL shall divert the Garia Nallah & Lapani Nallah within the land under their possession at their cost. All direct or indirect and annual expenditure on maintenance of the above said nallahs shall be borne by OCPL.
- Any adverse impact noticed due to the diversion must be set right by OCPL at its own cost.
- 4. The gradient of the diverted nallah shall be maintained by OCPL as per the L.S of the nallah vetted by Chief Engineer, Designs, DoWR.
- The design channel section shall be maintained in the proposed diversion alignment by OCPL. Smooth transition shall be provided between diversion and original nallah section by OCPL.
- Safe distance shall be maintained by OCPL from the diversion channel to the mining operation boundary for safety point of view following the Govt. norms.

- 7. OCPL shall ensure that riparian rights of the people residing in the downstream area not to be affected upon diversion of Garia Nallah & Lapani Nallah.
- 8. Both the water quality and quantity shall be maintained in-the nallahs by OCPL to ensure the protection of the riparian right of the inhabitants in the d/s of the diversion channel. OCPL shall not discharge/dispose any untreated and contaminated waste material into the nallahs so that the flora and fauna will be in peril. OCPL shall obey all the conditions mentioned in the environment clearance letter on water quality monitoring and preservation.
- 9. Ecological and environmental damages if any arising during and after diversion of nallah shall be the sole responsibility of OCPL for which they shall be treated as per law. OCPL shall have to obtain prior permission or clearance from competent authorities on ecology, environment & forest aspects as necessary.
- 10. The diverted nallahs shall be treated as public property.
- 11. Any construction activities/interference should be consistent with the hydraulic compulsions and structural safety standards.
- 12. OCPL shall ensure that the diverted portion of nallah is adequate to carry design discharge. In case any failure, change of the path of nallah is noticed after diversion, OCPL is liable for reconstruction at their cost and pay compensation if damage occur to public/private properties.
- 13. Necessary safety arrangement shall be the responsibility of OCPL while executing the diversion of nallah. The Company shall have to provide barricading, display boards and other necessary caution boards while executing the work.
- 14. Cutting of any tree or removal of any utility services along the proposed diversion alignment if required, OCPL shall have to obtain clearances from concerned approving authorities.
- 15. OCPL shall procure insurance from reputed insurance Company against damages during execution. In case of damages caused to any assets/life of any person due to diversion of nallahs, DoWR shall not be accountable or liable in any manner whatsoever.
- 16. OCPL shall intimate Revenue officials viz. Tahasildar & Collector of the district regarding such diversion in order to incorporate it in the cadastral map & ROR.



- 17. OCPL shall construct peripheral drains for discharge of flood water of the catchments coming under Mining Lease area if required.
- 18. The diverted nallahs are to be properly fenced and protected against accidents.
- 19. The interest of the local villagers is to be suitably addressed in the event of diversion.
- 20. OCPL shall make necessary arrangement so that seepage water from diverted nallah shall not enter into the mining area.
- 21. OCPL shall deposit the total compensation cost of Rs. 82.58 Lakh directly to the project authority and accord the necessary permission, further OCPL shall draw an agreement/affidavit with project authority to abide by the terms and conditions laid in the guideline issued by DoWR vide notification no. 4538 dt 24.02.2016.
- 22. The work should be executed in accordance with the Codal Provision with the overall objective of environmental safeguards. Latest codal provision and National/International best practices must be followed. DoWR shall not be responsible for any breach of the safeguards.
- 23. DoWR shall have the right to order any other works as may be necessary at any time during or after execution of diversion works to maintain the integrity of the nallahs. OCPL shall be bound to execute the same as per instruction of DoWR at its own cost.
- 24. DoWR shall reserve the right to inspect/ review/modify/revoke the permission in case of violation of terms and conditions of the permission.
- 25.CE & BM, Mahanadi Basin shall make intermittent visit to the work site to verify whether the nalla diversion is taking place in an integrated manner or not.

Madam.

I am directed to refer to State Govt. letter No10F(Cons)103/2020-9310/F&E dated 18.06.2020 on the above mentioned subject seeking prior approval of the Ministry of Environment, Forest & Climate Change under section 2 of Forest (Conservation) Act, 1980.

- 2. After due consideration of the proposal of the State Government and on the basis of decision of Regional Empowered Committee meeting held on 27.07.2020, the Ministry of Environment, Forest & Climate Change hereby conveys 'Stage-L'in-principle' approval for diversion of 5.777 ha of revenue forest land for construction of 33 KV Power Transmission overhead line from NTPC Darlipali to OCPL Sub-Station for use in Manoharpur Coal Mine Project by M/s Odisha Coal & Power Ltd. (OCPL) under Sundargarh Forest Division of Sundargarh district, subject to the fulfillment of the following conditions.
 - i. Legal status of forest land shall remain unchanged.

ii. Forest land will be handed over only after required non-forest land for the project is

handed over to the user agency.

iii. Compensatory afforestation shall taken up by the State Forest Department over 5.786 ha non-forest land identified in Plot No.64 & 104, Khata No.146 of village Diamunda under Lephripara Tahasil of Sundargarh district at the cost of the user agency. As far as possible, a mixture of local indigenous species shall be planted and monoculture of any species may be avoided.

iv. The non-forest land identified for raising compensatory afforestation shall be transferred and mutated in favour of the State Forest Department before issue of Stage-

v. The non-forest land over which compensatory afforestation will be taken up shall be notified as PF/RF and shall remain under the administrative control of the State Forest Department.

vi. The cost of compensatory afforestation at the prevailing wage rates as per compensatory afforestation scheme and at the cost of survey, demarcation and erection of permanent pillars if required on the CA land shall be deposited in advance with Forest Department by the project authority. The CA will be maintained for 10 years. The scheme may include appropriate provision for anticipated cost increase for works scheduled for subsequent years.

vii. The State Govt, shall charge the Net Present Value (NPV) for 5.777 ha forest area to be diverted under this proposal from the user agency as per the Orders of Hon'ble Supreme Court of India dated 30.10.2002, 01.08.2003, 28.03.2008, 24.04.2008 and 09.05.2008 in IA No.566 in Writ Petition (Civil) No.202/1995 and as per the guidelines issued by Ministry vide letter No.5-1/1998-FC (P1.II) dated 18.09.2003, as well as letter No.5-2/2006-FC dated 03.10.2006 and No.5-3/2007-FC dated 05.02.2009 in this regard.

viii. Additional amount of the NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Govt. from the user agency. The user agency shall furnish an undertaking to this effect.

ix. In hilly slope areas, sufficient ground clearance has to be maintained with additional height of towers in consideration of the sag and swing of lines and height of elephants to stop untoward incidence of electrocution as per existing guidelines of MoEF&CC dated 05.05.2014 and 19.11.2014.

x. The user agency shall restrict the felling of trees to minimum number in the diverted forest land and the trees shall be felled under the strict supervision of the State Forest Department and the cost of felling of trees shall be deposited by the user agency with the State Forest Department.

xi.All the funds received from the user agency under the project shall be transferred/deposited to State CAMPA fund only through (https://parivesh.nic.in/).

xli. The complete compliance of the FRA, 2006 shall be ensured by way of prescribed certificate from the concerned District Collector. The use agency shall submit FRA certificate before issue of Stage-II approval.

xiii. The user agency in consultation with the State Forest Department shall prepare a detailed scheme for creation and maintenance of plantation of dwarf species (preferably medicinal species) in right of way under the transmission line, and provide funds for execution of the said scheme by the State Forest Department.

xlv. The user agency at its cost shall provide bird deflectors, which are to be fixed on upper conductor of transmission line at suitable intervals to avoid bird hits.

xv. The user agency shall comply with the guidelines for laying transmission lines through forest areas issued by Ministry vide letter No.7-25/2012-FC dated 05.05.2014 and 19.11.2014.

xvi. The user agency shall obtain Environmental Clearance as per the provisions of Environment (Protection) Act, 1980, if applicable.

xvii. The layout plan of the proposed forest land shall not be changed without the prior approval of Central Government.

xviii.No labour camp shall be allowed in the forest area.

xix. Sufficient firewood, preferably the alternate fuel, shall be provided by the user agency to the labourer after purchasing the same from the State Forest Department or Forest Development Corporation or any other legal source of alternate fuel.

xx. The user agency while executing works, shall not fell any tree or damage forest growth in the surrounding forest area in any manner.

xxi. The boundary of the forest land to be diverted shall be suitably demarcated on ground

at the project cost, as per the directions of the concerned Divisional Forest Officer.

xxii.No additional or new path will be constructed inside the forest area for any activity related to the project work.

xxiii. The period of diversion under this approval shall be co-terminus with the period of lease granted in favour of user agency or the project life, whichever is less.

xxiv. The forest land shall not be used for any purpose other than that specified in the project proposal.

xxv. The forest land proposed to be diverted shall under no circumstances be transferred to any other agencies, department or person without the prior approval of Government of India.

xxvi. The State Govt. and user agency shall ensure compliance to provisions of the all Acts, Rules, Regulations, Guidelines, NGT Order (s) & Hon'ble Court Order (s) pertaining to this project, if any, for the time being in force, as applicable to the project.

xxvii. Any other conditions that the Ministry of Environment, Forests & Climate Change may impose from time to time in the interest of afforestation, conservation and management of flora and fauna in the area, shall be complied by the user agency.

xxviii. The compliance report of the Stage-I approval shall be uploaded on e-portal (https://parivesh.nic.in).

- 3. After receipt of the report on compliance to the conditions stipulated above, from the State Government of Odisha, final/Stage-II approval for diversion of the said forest land under Section 2 of Forest (Conservation) Act, 1980 will be issued by this Ministry. Transfer of forest land to user agency should not be effected by the State Government of Odisha till final/Stage-II approval for its diversion is issued by the Ministry of Environment, Forest & Climate Change.
- 4. However, to facilitate speedy execution of projects involving linear diversion, the inprinciple approval may be deemed as the working permission for tree felling and commencement of work, if the required funds for CA, NPV and all other compensatory levies specified in the in-principle approval are realized from the user agency, the State Govt. may allow the commencement of work of the linear project in forest land for a period of one year as per Para 11.2 of Chapter-11 of Handbook of Guidelines issued under F.C. Act, 1980 vide Ministry's letter No.5-2/2017-FC dated 28.03.2019.

Justification for proposing non-site specific activities on forest land:

- External OB dump (51.64Ha of Revenue Forest Land)
- Integrated Manoharpur and Dip side Manoharpur Mine is having an Annual Production Capacity of 16.0 Million Tonnes. The total volume of Overburden excavated during the life of the mine is 1747.41 M.Cum.
- Mine planning exercise has been done scientifically to minimize the external dump requirement & maximising internal dump capacity & to optimize transport lead distance. Out of total overburden of 1747.41 Mcum, 1579.49 M.Cum of overburden (more than 90%) can be dumped internally. Mine has been designed considering minimum damage to land & ecology.
- The remaining OBR quantity of 167.92 M. cum, which is 9.6% of the total OB, is required to be dumped externally in the eastern side of the coal mine within mine lease area which is also non coal bearing, there are no other space available for external dumping as both the blocks are surrounded by other coal blocks in all it's remaining three sides. External dumping towards dipside & rehandling the same into internal void is also not possible considering single quarry operation & non availability of void between working mine & dump slope, between haul road & dump slope at high depth of mine working.
- Two number of External OB Dumps have been proposed in the Mine plan mostly over non-forest land and keeping in consideration bare minimum use of forest land. From mining point of view single external Overburden Dump would have been a better proposition, however, to minimize the involvement of forest land, two external OB Dumps have been designed with an area of 33.50 Ha and 236.01 Ha respectively in which forest land is 4.88 Ha and 63.979Ha respectively. Forest patches located in this area are in scattered manner with crown density of less than 0.3 (Eco class-III).
- During development stage enough void will not be created for back filling of entire waste, requiring the external dumping of OB. Further when the mine depth

increases beyond 200m, stripping ratio will be increased with higher annual OB removal and the void created will not be sufficient for accommodating the entire OB generated, requiring external dumping of part quantity, i.e. around 74.14Mcum.

- ▶ Backfilling has been started in 2nd year itself. However due to limited void, simultaneous backfilling & external dumping have to be continued for certain years.
 Care has also been taken to accommodate maximum quantity within the designed external overburden dump area with minimum surface OB transport.
- The approved MP (Rev III) already considers a maximum dump height of 150m in the internal dumps and hence further OB can't be accommodated in the existing pit.
- Further the approved mine plan rev II accommodates only 58.89 MCum of OB in the external dump-III in an area of 175.57 Ha with a maximum height of 80 m. The approved MP (Rev III) accommodates around 152.5 MCum of insitu waste in the external dump-II (earlier ext. dump-III) in an area of 235.80 Ha with addition of 51.64 Ha of forest land. To minimize the usage of forest land, in the external area, the dumps are planned to a height of 120 m from the ground level and also the irregular shapes of dumps in earlier plan (rev II) were modified in MP (Rev III) to accommodate more volume of OB. The layout of both the plans is attached as **Annexure-1**.
- The location & height of external OB dumps as well it's design has been planned scientifically. These dumps have been planned considering individual tier of 30 m with maximum capacity, adequate safety berms & proper angle. Some of these forest patches are in the middle of proposed external dump. If these scattered patches of forest are avoided, then these dumps cannot be constructed with full capacity & height & there will be shortage in dumping space.
- In absence of these forest land, following are the disadvantages:
 - Huge additional non forest of equivalent area or more may be required in outside lease area for dumping which in turn leads to destruction of more land & further damage to ecology.
 - Increased cost of mining with more transport distance for OB, transportation of OB outside lease area will further enhance pollution.

- Considering the technical and safety point of view, the forest patches are minimum requirement. Thus, total exclusion of the forest land in OB dump area is unavoidable considering the site condition and bare minimum use of forest land has been planned.
 - Railway Siding (0.27Ha of Forest Land) & Approach Road (8.67Ha of Forest Land)
 - ➤ Integrated Manoharpur and Dip side Manoharpur Mine is having an Annual Production Capacity of 16.0 Million Tonnes. The mine is captive to 4x660MW units of Ib Thermal Power Station of OPGC.
 - ➤ The coal requirement of the Captive units is envisaged as 14 to 16MTPA depending on Plant Load Factor and Specific Coal Consumption of the station.
 - > The entire coal is envisaged to be transported through a dedicated 47km double track Merry-Go-Round (MGR) system from mine to power plant.
 - ➤ At present two units (2x660MW) are under operation and the entire coal requirement is met from the captive mine through the single line MGR track. Remaining two units and second line of the MGR system are envisaged to be commissioned by FY2029-30 as per the Govt. approval.
 - As per the efficiency parameters of coal block Allotment Agreement signed with Ministry of Coal, GoI, the coal company needs to adhere the production schedule of Approved Mine Plan.
 - ➤ As per the Approved Mine Plan, Integrated Mine has to produce 10MT in FY23-24, 13MT in FY24-25 and 16MT from FY25-26 onwards.
 - ➤ Accordingly, there will be excess coal from the mine and the quantum of excess coal is depending on the coal requirement of OPGC.





- > To avoid the road transportation of excess coal it has been planned to connect the mine with Indian Railway system by constructing a Railway siding near Laikera village, which is at a distance of only 5.4 Km from the mine.
- ➤ A dedicated concrete road will be developed from mine to the proposed Railway siding, which enables minimum road transportation, thereby reducing the air pollution to a greater extent.
- ➤ Thus, the proposed diversion of Forest land for construction of Siding and its approach road is essential for evacuation of coal with minimum damage to the environment.
