

In compliance of the Ministry of Environment and Forest (MoEF), Government of India's letter No.11-9/98-FC (pt.), dated.3rd August, 2009 wherein the MoEF issued guidelines on submission of evidences for having initiated and completed the process of settlement of rights under the Scheduled Tribes and Other Traditional Forest Dwellers (Recognition of Forest Rights) Act, 2006 (FRA for short) on the forest land proposed to be diverted for non-forest purposes read with MoEF's letter dated.5th February, 2013 wherein MoEF issued certain relaxation in respect of liner projects, it is certified that **0.9723** Hectares for forest land in **Compt.No.72 of Nellikal Reserve Forest of Amrabad Tiger Reserve of Nagarjunasagar Wildlife Division** proposed to be diverted in favour of **R&B National Highway** (name of user agency) for **widening and upgradation of Nakrekal - Nagarjunasagar for strengthening of existing BT Road from Km.72/460 to 73/395 (0.935 KM)** (purpose for diversion of forest land) in **Nalgonda** District.

- (c) The proposal does not involve recognized rights of Primitive Tribal Groups and Pre-agricultural communities.




