Agreement in connection with the transfer of Mining lease for China Clay near village Tatori, Tehsil Kotputli, District Jaipur.


This Indenture made this 1st day of November, 1973, between the Governor of Rajasthan (hereinafter referred to as the State Government which expression shall where the context so admits be deemed to include the successors in office and assigns) of one part and M/s Shri Modi Levigated Kaolin (P) Ltd., Neem ka Thana, District Sikar (hereinafter referred to as 'Transferee') which expression shall where the context so admits be deemed to include his heirs, executors, administrators, representatives and permitted assigns) of the other part;

WHEREAS by virtue of an agreement of lease (hereinafter called the 'Lease') dated the 6.10.1967 made between the Governor of Rajasthan (hereinafter called the 'Lessor') and M/s Shri Modi Minerals Grinding Mills (P) Ltd., Neem ka Thana, Distt. Sikar (hereinafter called the 'Lessee') was granted a lease of China Clay near village Tatori, Tehsil Kotputli, District Jaipur, for a period of twenty years with effect from 19.6.68 and the lessee is and was entitled to search for and work the mines and minerals therein mentioned on the terms and conditions mentioned in the lease deed and subject to the rules and regulations in force. Lessee's covenant was to pay deadrent, royalty and not to assign the lease or any interest thereunder without previous sanction of the Lessor.

WHEREAS the lessee was desirous to transfer the lease to M/s Shri Modi Levigated Kaolin (P) Ltd., Neem ka Thana, District Sikar, and the lessor has at the

request of lessee granted sanction to such transfer and assignment upon the condition that the lessee is to execute a transfer deed in favour of the transferee and transferee would execute bond on stamp to comply with all the terms and conditions provided in the lease deed dated 6.10.1967 and the rules and regulations in force.

WHEREAS the lessee has been permitted under Government order No. F.3(1)(25)Khani #/61 dated 5.10.70, to transfer the said lease to N/S Shri Mdli Levigated Keonjin (P) Ltd., Neem ka Thana, District Sikar (hereinafter called the 'Transferee').

In pursuance of the Government order No.3 (1)(25)Khani #/61 dated 5.10.1970, a transfer deed has been executed between the lessee and the transferee on 1st July, 1971 and the same has been registered on 4.10.1971.

NOW IT IS HEREBY AGREED AND DECLARED by the Transferee with and to the Government of Rajasthan that from and after the transfer and assignment of lease by the lessee to the transferee, the transferees shall be bound by and liable to perform and observe and owing -in to and be subject respectively to all the provisions and conditions of all the covenants and stipulations contained in the lease in the same manner in all respects as if the lease has been granted to the transferee as the lessees herunder and they have originally executed it as such and the transferees hereby undertake and agree with the Lessor to perform and observe all the covenants and stipulations and conditions -in all respect accordingly and abide by the rules, regulations, orders and directions issued by any officer of the Department of Mines and Geology and further undertake that they shall not put the lessor to the loss of royalty by making fictitious sale and transfer to sister concern below the normal rates.






