A proposal has been received by this office from **National Highways Authority of India** for diversion (Under FCA-1980) of **24.585 ha.** Forest land for non-forestry purpose. The project envisages the use of forest land for **Four Laning of N.H.-111 (Km. 0.000 to 53.300)** in Distt. Bilaspur. The site inspection of the land involved in the proposal has been done by me on **14/05/18.....**

On inspection of the site, it is found that the land required by the user agency is a **Revenue Forest** measuring **24.585 Ha.**
