Please refer to Ministry's letter No. RW/NH-12017/960/2010/HR/NH-1 dated 24.05.10 (copy enclosed) forwarding therewith above mentioned NOC case after its approval. The case has been approved and license deed has been signed by competent authority in Ministry. One copy of license deed papers and layout plan duly signed by the Chief Engineer (P-1), MORT&H, Govt. of India on behalf of President of India on 24.05.10, are being forwarded subject to the condition that the instruction written/modification made etc on the drawing of layout plan should be compiled with. Copy of Ministry's letter is also enclosed herewith.

The license agreement is valid till 23.05.2013 [C1 4(xvi) of license deed]. The licensee shall get the license agreement renewed well before the expiry of the agreement. It may be ensured that licensee complies with the requirements as per approved NOC proposal. As per clause 4(i) of license deed, the licensee has to maintain the approach road as per approved drawings & specification. The EE PWD would send the report in this regard and the same EE PWD shall inspect the site after three months & shall inform the status of construction/maintenance of acceleration/deceleration lane to this office.

Non-compliance of any condition mentioned in approved license deed will attract cancellation of license through the EE PWD as per license deed.
