Subject: Diversion of 0.075 Ha of forest land for construction of parking Place
at Dalhousie within the jurisdiction of DFO Dalhousie.

Sir,

Kindly reference is invited to the letter received from MOEF
Government of India vides which the objections has been raised.

In this context, I have the honour to submit that the above case has
been reconsidered and the point wise comments for justification for this case is as
under:-

1. That the land proposed for the Construction of above parking is in the possession of M.C.Dalhousie and this area does cover under DPF. But the classification of the land is Jungle due to which the FCA attract. The Revenue paper of the above land before 1980 and for the year 2024-25 are also attached in which the status and possession of land is shown.
2. That the Municipal Council Dalhousie is the oldest Municipal Council which is established 1968. The most of the area in Municipal Council Dalhousie is hilly and trees are standing from corner to corner and there is no non forest land in the possession of M.C.Dalhousie.
3. That the Municipal Council Dalhousie is most popular hill station and tourist destination. There are 3 popular tourist destination for local site seeing in M.C.Area i.e. Subhash Chowk, Gandhi Chowk and Punjpulla, and the tourists visit in these places in separate time in separate place and due to long distance between these places, the parking places are urgent required.
4. That This Multistoried parking project prepared in view of the above for 70 vehicles which will be sufficient in this area for next 30 to 35 years.
5. That as per discussion with the DFO Dalhousie the site has been visited, there are 8 trees standing in the proposed area out of which 4 will be retained as these trees are standing at the corners of the proposed site which are not required to fell. The list of trees required to cut and retained is enclosed.

It is, therefore, kindly requested to resubmit the above FCA case to the Government for approval please.


