Sub: Forest (Conservation) Act, 1980 – Villupuram Forest Division / Villupuram Forest Circle – Proposal for diversion of 0.1616 ha. of forest land for reconstruction of dilapidated head sluice, bed dam, retaining wall and culvert in Malattar channel for supplying of water to Tirukoilur and Ulundurpet Taluk tanks in Villupuram District – Shortcomings pointed – Revised proposal submission of – Reg.

With reference to the above subject, I submit and enclose herewith the details called for in the Principal Chief Conservator of Forests reference 2nd cited as follows:

1. The proper competent authority certificate has been received from the authority and uploaded in the portal.
2. The component wise break up details for the forest area required is given with length and width details.
3. Corrected .kml files are uploaded for the required diversion of land and location of the diversion.
4. Topo sheet has been prepared and uploaded in the portal.
5. Clear details of geo coordinates is uploaded with dgps map.
6. Action is being taken to obtain the certificate issued by the District Collector on completion of process for settlement of Rights under the Forest Right Act, 2006. The certificate will be uploaded soon.
7. Non availability of non-forest land certificate from the District Collector is uploaded in the portal.
8. Malattar channel in Malattar river bed forest area is selected for these works.
9. All the area selected for the works are located only on the river bed and structures are in the dilapidated in condition.
10. Fresh drawing regarding structures are uploaded.

11. All necessary certificates are uploaded in the portal.

- a. Detailed area requirement statement is enclosed.
- b. Clear copy of google earth map is enclosed.
- c. Certificate regarding area demand for the project is barest also enclosed.
- d. Undertaking for the NPV of the proposed diversion of forest land as per the value fixed by the Supreme Court of India is uploaded.
- e. Undertaking for the additional NPV of the proposed diversion of forest land as per the value fixed by the Supreme Court of India is uploaded.
- f. Undertaking to deposit the cost of raising compensatory afforestation / Penal compensatory afforestation / maintenance of plantation / protection of plantation for the proposed diversion of forest land as fixed by the forest department is uploaded.
- g. Undertaking to pay the cost along with any escalation for cutting and transportation of tress if any available in the project area as fixed by the forest department is uploaded.
- h. Undertaking to pay the cost towards lease rent as fixed by the forest department at the time of sanction along with any escalation in future for the forest land to be diverted of the above project is uploaded.
