**Subject: - Proposal for Permission to lay Optical Fiber Cable underground through HBD method in Sector-5, U.E., Karnal.**

Please refer to your application dated 25.04.2019 on the subject cited above.

As recommended S.D.E, HSVP, Sub Division No. 1, Karnal and amount of BT bill deposited by the firm for Rs. 359705/- (Less 10% TDS on Rs. 305750/-) = 329130/- and the bank guarantee of Rs. 600000/- vide receipt No. 075423 dated 15.05.2019, the permission for the laying of **Optical Fiber Cable under in HSVP Sector-5, U.E. Karnal** cited as subject is hereby accorded is the condition as under:-

1. The road cut should be avoided. The **Optical Fiber Cable** should be laid by trench less method and by boring under the metalled portion of roads otherwise the panel rates will be charged as decided by the under signed latter on as per site condition.
2. Private ramp and other structures damaged due to laying of OFC will be got repaired by the agency at his own cost.
3. If there is any accident/miss-happening occurs during execution then the agency will held responsible for the same.
4. The permission is further subject to audit and any other charges as and when demanded by HSVP shall be deposited by agency.
5. The prior approval may be obtained from the undersigned for making connection to any house on later stage otherwise the panel rate would be recovered from yourself.
6. The validity of execution of work is thirty days, however no further extension shall be granted.
7. The permission is granted for laying of underground cable only for **6000 Mtr.** length and is not for additional length. The prior approval shall be obtained before connection to the allottees and laying the additional length.



8. The trench excavated for laying of Optical Fiber Cable **M/s Jio Digital Fiber Private Limited** would be refilled in proper layer duly compacted /watered within three days positively to avoid any accident/inconvenience to the residents in habitant area.
9. All the underground Water/Sewerage/Storm water system etc. of HSVP shall be protected. In case of any damaged to underground system/pipe line damaged during execution than said system shall have to be repaired cable **M/s Jio Digital Fiber Private Limited** immediately to avoid any inconvenience to the public at their own cost.
10. The security fees bank guarantee deposited by the firm i.e. **Rs. 600000/-** will be refunded only after **Six Months** from the completion of work and submitted the satisfactory site report by the concerned SDE.
11. Any other taxes, cess etc. shall be deposited by agency as and when demanded by HSVP.
12. All other direction issued by higher authorities of HSVP shall be applicable in this matter.
13. The annual lease charges are valid for 5 years only. The lease charge will be fixed after a period of five years of another block of five years and so on and so for other w.r.t. the circle rate applicable at the time and will be deposit by the agency.
14. All terms and condition regarding validity/permission as per notification dated Sept. 2017 shall be applicable.

**Note: -** That the agency shall remain bound to submit TDS certificate in the stipulated time mentioned in the undertaking dated 25.05.2019.
