आपत्तियों का निराकरण निम्नवत् है-

1	It is seen from the KML file of the proposed road that the road starts from dense forest and connected another Road Benefitted village 'Ghena' seems too far from the proposed road and only a few scattered houses are seen. State Government May review the same and submit clarification along with actual location of village 'Ghena' on KML file	The proposed road starts from another road due to dense forest the another road not seen. The 'Ghena' village is at the end point of proposed road.
2	The KML file of CA area is uploaded for 6.535ha. instead of 4.463 ha which seems incorrect. As per DSS analysis of the area, it is seen that the whole area is falling in MDF. Further the shape of two patches of CA in KML file and digital map do not match. State Government may submit the KML for 4.463ha area.	Now the KML of CA area is Uploaded for 4.463 ha.
3	In place of uploading ownership proof CA site suitability certificate is found uploaded. State Government may upload the ownership proof of CA area at para L Part I online.	Now ownership proof is uploaded.
4	Work not start and aerial distance certificate are not found uploaded. State Government may upload the said documents online.	Work not start and aerial distance certificate is uploaded.
5	In the land schedule some corrections have been made. State Government may authenticate the corrections made in land schedule.	Correction has made and uploaded.
6	Two CA scheme submitted for same area for amount Rs. 230302/- and Rs. 1158962/- State Government may provide clarification in this regard.	Two CA scheme submitted same area for different amount due to revised of Rates and correcte CA scheme uploaded.
7	Certifcate to bear additional NPV is not found submitted. State Government may Submit certificate to bear additional NPV in original.	NPV certificate uploaded and original certificate all ready attached in original file.
8	State Government may submit hard copy of the above mrntioned documents in original.	Correction in the hard copy (original papers are given for attached in forest file.) is submitted
