(I) Relevant records pertaining to non-forest land, Revenue lands, ***zudpi jungle, Chhotejharka jungle, bade jharka jungle, jungle jhari land, civil-soyam land*** and all other such categories of forest lands (except the forest land under management and administrative control of the Forest Department) on which the provisions of Forest (Conservation) Act, 1980 are applicable, available in Dhalai District of Tripura State have been examined, and

(II) I have also conducted such further enquiry as is required to satisfy myself for issue of this certificate. On the basis of examination of relevant records and such further enquiry, as was required for issue of this Certificate, I do here by certify that non-forest land, revenue lands, ***zudpi jungle, Chhotejharka jungle, bade jharka jungle, jungle jhari land, civil-soyam land*** and all other such categories of forest lands (except the forest land under management and administrative control of the Forest Department) on which the provisions of Forest (Conservation) Act, 1980 are applicable, which as per the extant guidelines of the Central Government may be utilized for creation of compensatory afforestation in lieu of forest land diverted for non-forest purpose, is not available in the entire Dhalai District of Tripura State.
