
With reference to the above subject proposal to lay 6.1 kms of 6"dia. CS & 125 mm dia MDPE Natural Gas Pipeline on Bareilly - Shahjahanpur Road along RHS of NH-30 from chainage 262.000 (Tata Motors) to chainage no. 268.100 (KEO, Bareilly). The Competent Authority vide their letter dated 27.12.2021 ref. (5) above has accorded the approval of the subject matter and Authorized the Project Director on behalf of NHAI for signing of License Agreement with the Applicant, subjected to take compliance of the following conditions for further necessary action by this office:

1. The Crossing / laying will be done as per the proposed/agreed location route and as per proposed layout plan and as per MoRT&H Guidelines dated 22.11.2016.

2. The License shall have to provide the safety measures like barricading danger lighting and other necessary caution boards while executing the work.
3. Appropriate fees be levied for use of NH land for laying of Utilities as per Ministry Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016.
4. Laying work should be carried out as per Ministry circular no. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016.
5. It shall be the responsibility of the Applicant to ensure the safety and maneuverability of Highway Traffic during laying of Gas Pipeline.
6. The Applicant is responsible for the details provided in the application. The NHAI is at liberty to verify the authenticity of the documents at any time. Any misrepresentations, omission or suppression of facts or disclosure of incomplete misrepresentations, omission or suppression of facts or disclosure of incomplete facts detected at any stage shall lead to withdrawal of this approval with cost to the applicant.
7. In view of any future development requiring necessary alteration, including complete removal or shifting of the Gas Pipeline, the same shall be carried out by the applicant at its own cost to the satisfaction the Highway administrator.
8. In case of violation of the norms of Ministry's Guidelines, the NOC automatically stand withdrawn.
9. IRC: 98-2011 should be complied wherever applicable.

Moreover, you are also requested to submit the following undertakings:

- a. Three copies of "As laid drawings" of utilities (Hard and Soft copies) shall be submitted to Highway Authorities for verification and record within a month of completion of works.
- b. The permission may be terminated immediately on violation of the agreed terms & conditions.
- c. The execution of the proposal by the Applicant would not hinder the future widening, if any, at the particular location and if required then the applicant would ensure shifting of their utility at their own cost without any liability to NHAI in a time bound manner prescribed by NHAI.



- d. Ensure that the submitted Agreement is in prescribed format as per Ministry circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 for execution with the applicant, and BG be obtained as per the Circular.
- e. Work programme from the applicant may be obtained and ensure timely completion.
- f. The compliance of various undertakings given by the applicant may be ensured before and after signing of License Agreement, as the case may be in the interest of safety of road users and NHAI.

In view of above, you are requested to compliance the above at the earliest and requested to be present with above compliances along with Original License Agreement on any convenient date as per your discretion with the prior intimation to this office for carrying out formalities of signing the Agreement for the subject proposal, so that the further necessary action for Permission/NOC can be taken.

Please refer to your letters under reference vide which you had submitted the subject proposals. Subsequently the same were forwarded to Competent Authority i.e. RO-UP (West), NHAI, Lucknow for necessary approval.

2. In this regard, it is to inform that the matter has been examined in accordance with MoRTH Guidelines No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 and as requested, the Competent Authority i.e. RO-West UP, NHAI, Lucknow has granted the approval vide letter no. 18001/1/RO-W-UP/NH-30/M-B/Ch.260.300-262.000/NOC/2209 dated 09.06.2023, subject to ensuring the compliance of following conditions before according permission:-

- (i) The laying work will be done as per the proposed/agreed location route and as per proposed layout plan.
- (ii) The licensee shall have to provide the safety measures like barricading, danger lighting and other necessary caution boards while executing the work.
- (iii) Appropriate fees be levied for use of NH land for laying of Utilities as per Ministry Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016.
- (iv) Undertaking to the following effect may be submitted by the applicant and made part of the agreement:-
 - (a) Three copies of "As Laid Drawings" of utilities (hard and soft copies) shall be submitted to Highway Authorities for verifications and record within a month of completion of works.

- (b) The permission may be terminated immediately on violation of the agreed terms & conditions.
- (c) The execution of the proposal by the Applicant would not hinder the future widening, if any, at the particular location and if required then the applicant would ensure shifting of their utility at their own cost without any liability to NHAI in a time bound manner prescribed by NHAI.
- (d) Ensure that the submitted Agreement is in prescribed format as per Ministry Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016 for execution with the Licensee.
- (e) Licensee has to submit the work programme and ensure timely completion as per programme.
- (f) The compliance of various undertakings given by the Applicant may be ensured before and after signing of license agreement, as the case may be in the interest of safety of road users and NHAI.
- (v) Laying work should be carried out as per MoRT&H Guidelines RW/NH-33044/29/2015/S&R(R) dated 22.11.2016.
- (vi) It shall be the responsibility of the Applicant to ensure the Safety and maneuverability of Highway Traffic during laying of pipeline.
- (vii) The approval is based on the submissions made by Applicant. The Applicant is responsible for the details provided in the application. The NHAI is at liberty to verify the authenticity of the documents at any time. Any misrepresentations, omission or suppression of facts or disclosure of incomplete facts detected at any stage shall lead to withdrawal of this approval with cost to the applicant.
- (viii) In view of any future development requiring necessary alteration, including complete removal or shifting of the Natural Gas Pipeline, the same shall be carried out by the Applicant at its own cost to the satisfaction the Highway Administrator.
- (ix) In case of violation of the norms of Ministry's Guidelines, the NOC automatically stand withdrawn.
- (x) IRC:98-2011 be complied wherever applicable.

3. The above approval has been granted by Competent Authority on the basis of submitted BG bearing no. 6288NDLG00025122 dated 29.10.2021 (which has been expired on 27.10.2022) amounting to Rs. 1,70,000/- with the condition that appropriate Extension of the BG may be obtained from applicant in accordance with Ministry Circular No. RW/NH-33044/29/2015/S&R(R) dated 22.11.2016, before signing of License Agreement. As such, you are requested to furnish the extension of said BG for minimum period of 1 year alongwith an undertaking that the said BG shall be extended time to time till satisfactory completion of work.

4. In view of above, it is, therefore, requested to submit the above compliance alongwith all the undertakings mentioned above, at the earliest so that license agreement for the said work could be executed.
