However, we are again including the Rund Mojpur Forest Block for Joint verification.
3.	Chainage has not been mentioned in the DGPS and GT Toposheet.	Complied
4.	Forest Block has not been mentioned in the DGPS Map.	Complied
5.	Area calculation sheet of Non -forest area has not been mentioned in the proposal.	Village wise forest and non forest area breakup is provided under Section B-2.3 Part-1 (Form-A).
6.	Revenue map needs to be submitted in the scale of 1:4000.	Complied
7.	Page numbering has not been done in the index.	Complied
