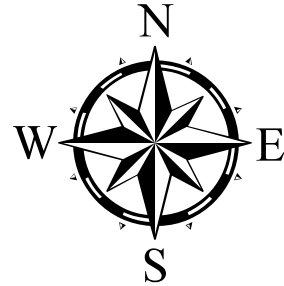


GOOGLE MAP SHOWING THE PROPOSED COMPENSATORY AFFORESTATION LAND OVER AN AREA OF 1.65 HA
