Sub: - Submission of Proposal for Diversion of 136.966 Ha (94.013 Ha in Baliguda Forest Division & 42.953 Ha in Kalahandi North Division) of Forest Land for non-forest purpose under Forest Conservation Act, 1980 for Construction of 220 KV DC Transmission line from existing 220/132/33 KV Grid Sub-Station at Kesinga, Kalahandi District to proposed 220/32 KV Grid Sub-Station, Baliguda at Sirtiguda in Kandhamal.

With reference to above cited letter we are complying herewith the discrepancies noticed at your end in our diversion proposal. The point wise details are as follows:-

Point No: - 1

Mismatch of total forest area required for diversion of Tumudibandha Tahasil as mentioned in Table No. 1 (A) of Page No. 15 with Table No. 2 of Page No. 17.

Compliance:-

In compliance to the above project, it is to inform you that the actual forest area proposed to be diverted in Tumudibandha Tahasil is 16.791 Ha, which has been mentioned in Table-1. But due to typographical mistake it is mentioned is 16.971 Ha in Table-2. Accordingly, Table No. 2 has been modified and enclosed in Page No. 17 in the Diversion Proposal.

Point No: - 2

The Signature of concerned Tahasildar (coming under Baliguda and Kalahandi North Forest Division) are not there on the Survey of India Topo sheet maps enclosed in Plate-1 & Plate-2.

Compliance:-

In compliance to the above point necessary signature has been done by Tahasildars / Forest Range Officers concerned in Plate No. 1 & 2 and enclosed in Diversion Proposal.

Point No: - 3

The Length and width of the proposed transmission line RF, PRF, DPF, Revenue, Forest, Non forest Govt. and Non-forest private land should be mentioned.

Compliance:-

In compliance to the above point necessary information is enclosed in the Diversion Proposal and Page No. 3(B).

Point No: - 4

Compensatory Afforestation Scheme and DSS study report are not enclosed in the Project.

Compliance:-

In compliance to the above point, we have submitted 4 no. of CA schemes to Divisional Forest Officer, Kalahandi North Forest Division vide our letter no. 135(6), dated 02.03.2023. The copy of the letter is enclosed. 1 no. of CA Scheme prepared by Divisional Forest Officer, Subarnapur Forest Division over an area of 100 Ha of Degraded Forest Land identified in Hatlimunda Reserve Forest under Biramaharajpur Range, which has been submitted to you vide his letter no. 2042/4F Misc./72-2021, dated 29.04.2023. The copy of the letter is enclosed.

Point No: - 5

As per Form A(ii), name of the project for which forest land is required is construction of 220KV DC Transmission line from existing 220/132/33 KV Grid Sub-Station at Kesinga, Kalahandi District to proposed 220/32 KV Grid Sub-Station at Sirtiguda in Kandhamal but on scrutiny it is seen that in Annexure -6~&~7 and forest land schedule, Non-forest land schedule, Non-forest private land schedule of concerned Tahasil of said proposal it has been mentioned that the proposed Grid Sub-Station at Baliguda in Kandhamal. Hence in this regard you are requested to clarify in which site the Grid Sub-Station under the aforesaid project is going to be taken up.

Compliance:-

In compliance to the above point, it is inform you that, when the substation was planned to be constructed in Baliguda Region, the name Baliguda has been given, but finally the land was allotted by district administration in the village Sirttigura under Baliguda Sub-Division. The substation was planned for the benefit of the people of Baliguda area that's why the project name was given Bbaliguda and the line name was given from Kesinga to Baliguda. But it is the same project.

We are submitting herewith 5sets of EDS compliance documents and maps raised by you. We would therefore request you to kindly process and forward the proposal to appropriate authority.
