
With reference to the 7th cited, it is informed that in the reference 9th cited, the CA Scheme proposals to the proposed Non-Forest land for CA to an extent of 5.15 Ha in Sy.No.1018, 1019, 1020, 1021 and 1022 of Allinagaram Village, Komarole Mandal, Prakasam District in lieu of Diversion of 4.49 Ha of Forest Land in Compt.No.127 of Kondaveedu RF, Peerecherla (Village), Medikonduru (Mandal), Guntur District for extraction of Road Metal and gravel to a tune of Rs.79.000 lakhs along with relevant datas in (5) sets were submitted to the Conservator of Forests., Guntur with a request to approve the CA Scheme for incorporation in Section 2 proposals of Guntur(T) Division.
