Subject: - Permission for laying of water supplying pipe line along Gurugram Badli road and crossing of road of raw water inlet pipe line near water works Iqbalpur.

Reference: - Your office letter no 315 dated 12/04/2021

Permission is hereby accorded for laying of water supply pipeline along Gurugram Badli road and crossing road of raw water inlet pipe near water works Iqbalpur as per drawing supplied by your good office, subject to the following conditions:-

1. That the work should be done by Horizontal Directional Drilling (HDD) method. No open digging will be allowed.
2. It will be insured that the work should be done at the extreme edge of PWD land.
3. It should be insured that smooth flow of traffic during execution of work.
4. It should be insured to back fill the earth and restore the land level to its original shape.
5. The all safety measures during execution of work as per norms should be taken at site, if any mishap occurred during execution of work. It will be the soul responsibility of your Department.
6. It should be ensured that no damages occurred to the existing services like water supply lines, Sewerage line, Telephone Line, Cables etc and if such damage occurs then same will be repaired at your own cost.
7. Your Department will remove / Shift pipeline at their own cost whenever required by this Department at the time of upgradation of this road and no compensation will be claimed by PHED Department.
8. That the work of laying pipeline should be got done strictly as per agreement.
