

1.	The user agency had sublimated a proposal for the diversion of 2.4503 ha for mining lease and approach road to quarry site for already established stone crusher vide proposal no. FP/HP/Min/33172/2018. Being incomplete, the proposal was returned to user agency online vide this office letter dated 21.04.2018. No reply to this office observation was given by the user agency till date and the proposal is still pending at user agency level since 25.04.2018. Now a new proposal for the diversion of 2.1532 ha of forest land for mining lease, approach road and staking of raw material for already established stone crusher at Pashada has been uploaded by the user agency on 16.6.2018. if the earlier uploaded proposal is not required to be processed, the proposal alongwith request for withdrawal of that proposal is required to be forwarded at Nodal Officer level.	The project proponent has submitted a request letter for withdrawing the proposal no. FP/HP/Min/33172/2018. Request letter enclosed as Annexure I.
2.	It is also required to be clarified by the user agency whether the forest land already diverted for the construction of stone crusher and quarry site, for the already established stone crusher has been included in the present proposal or not.	M/s Bhushahr Laghu Udyog was applied forest clearance renewal proposal vide letter no. FFE-B-F(2) 17/2005 dated 22.02.2005 for the period of 15 years and approval was granted vide letter no. 9-HPB 414/1997 dated 18.02.2006. FCA approval letter is attached as Annexure-II.
3.	Against column No.C(ii)a, although the KML file of the proposed project has been uploaded but while viewing the KML file on google earth, the same is not visible. The revised KML file of the forest land	Revised KML file has been uploaded.



Sub Diversion of **0.2898 hectare** (instead of 0.5448 hectare) of forest land in which the **quarry site is only 0.1964 hectare** in favour of Bushahr Laghu Udyog, Pashada for mining and installation of stone crusher under Rampur forest division, District Shimla, Himachal Pradesh.

Sir,

I am directed to refer to Government of Himachal Pradesh letter No FFE-B-F(2)17/2005 dated 22<sup>nd</sup> February 2005 and letter from Nodal Officer (FCA)-cum-CF (P&L) letter No. Ft.48-314/97 (FCA) dated 14<sup>th</sup> August 2006 on the above mentioned subject seeking prior approval of the Central Government in accordance with Section-2 of the Forest (Conservation) Act, 1980.

After careful consideration of the proposal of the State Government, **approval of the competent authority is hereby conveyed** for diversion of **0.2898 hectare** (revised) of forestland for the above mentioned subject to following conditions:

1. Legal status of the forest land will remain unchanged.
2. No tree felling is involved in this case.
3. The forest land will not be used for any purpose other than that specified in the proposal.
4. An undertaking from the user agency may also be obtained stating that in case the rates of NPV are revised upwards, the additional/differential amount shall be paid by the user agency.
5. User agency shall construct 8.00 ft high retaining wall at its own cost towards crusher site to avoid rolling down of debris in the adjoining nullah.
6. Safety zone area will be properly fenced and maintained at the cost of user agency. CA plantation will be carried out over 1.5 times of the safety zone area as per proposed scheme at a cost of Rs. 20,000/- (rupees twenty thousand only) which is reported to have already been deposited by the user agency. Plantation will be done within one year from the date of issue of this letter.
7. Recommendations of the approved mining plan w.r.t mining and operations will be strictly adhered to.
8. No damage of any kind will be caused to the adjoining forest area and all the protection/ precautions measures as suggested by the Geologist in his report for stability of the forest area be strictly adhered to.
9. It will be responsibility of the State Government to obtain prior approval/clearance under all other relevant Acts/Rules/Court's Rulings/instructions etc. as applicable to this proposal.

The Ministry may revoke/suspend the clearance if implementation of any of the above conditions is not satisfactory. State Government will ensure fulfillment of these conditions through forest department.
