In the reference cited, the Commissioner of Fisheries, Fisheries Department, Teynampet, Chennai 6 has furnished online application under Section 2 of Forest (Conservation) Act, 1980 for diversion of 0.715 ha of Pulicat Lake Sanctuary of Wildlife Division, Chennai for construction of fish landing centres at Annamalaichery and Periyamangodu village in Tiruvallur District

The User Agency has not furnished the following essential Documents / Undertakings / Certificates for the project. Further the following defects / shortcomings have been noticed in the proposal.

- 1) Certificate on no violation of the provisions of Forest (Conservation) Act, 1980 occurred has not been furnished.
- 2) Certificate of demand for forest land required for the project is minimum and unavoidable and all the alternative has been examined for the project has not been furnished.
- 3) Undertaking to deposit the cost of Raising Compensatory Afforestation along with maintenance of plantation as and when demanded by the Forest Department has not been furnished
- 4) Undertaking to pay the lease rent as and when demanded by the Forest Department has not been furnished.
- 5) Undertaking to pay the amount of Net Present Value which will be fixed by the guidelines of Supreme Court of India has not been furnished
- 6) Undertaking to bear the additional Net Present Value which will be fixed by the guidelines of Supreme Court of India as fixed by Forest Department in future has not been furnished
- 7) Undertaking to bear the cost of felling of trees and transportation cost of the trees to be removed if any available in the alignment path for the proposed diversion of forest land as fixed by the Forest Department has not been furnished.
- 8) Certificate obtained from the District Collector about completion of process of settlement of rights under the scheduled Tribes and other traditional Forest Dwellers (Recognition of Forests Rights) Act 2006 has not been uploaded
- 9) Certificate obtained from the District Collector about there is no suitable and technically approved alternate non forest land available for the project has not been furnished
- 10) The User Agency has not furnished / uploaded the copy of conditions stipulated by the Chief Wildlife Warden on getting clearance of NBWL (under Segment I. Status of Wildlife Clearance).
- 11) The User Agency is requested to upload the authenticated copy of note containing the justification for locating the project in forest land.

12) The User Agency is requested to upload the approval of Supreme Court of India for the projects. (For construction of fish landing centre with allied infrastructure at Annamalaicherry and Periayamangodu villages).

13) The User Agency is requested to upload the Standing Committee of NBWL approval for diversion of forest land in Pulicat Birds Sanctuary for construction of fish landing centre at Annamalaicherry village.

14) The User Agency is requested to clarify that, the Standing Committee of National Board for Wildlife has accorded approval for diversion of 0.65 ha of forest land from Pulicat Birds Sanctuary for construction of fish landing centre at Periyamangodu village. But proposal has been furnished for 0.38.0 ha only. Reason for the variation may be reported/uploaded.

15) The User Agency is requested to furnish the component wise details of land required for the villages separately.

16. The User Agency is requested to upload the geo reference details (GPS readings) of the project sites.

The User Agency is requested the above defects may be rectified and the details / certificates may be uploaded, hard copy also furnished.

If any correction'/ modification additional documents uploaded in the proposal, those details may also be furnished in hard copy to this office.
