Subject: Diversion of 0.99Ha of Forest and in Survey No: 52 & 53 of Panathur Village, Varthuru 2 Hobli, Survey No:109 of Gunjurpalya Village, Varthuru 1 Hobli, Bengaluru East Taluk, Bengaluru Urban District for Widening and Formation of 30.00Mtrs Wide Road from Kundalahalli (Old Airport Road) to Gunjur Palya via BWSSB Treatment Plant (Road upto Gunjurpalya Main Road) as per RMP-2015, In favour of Executive Engineer Road Infrastructure Mahadevapura Division #105, 1ST Floor, Annex Building-3, NR square, BBMP Bengaluru Urban district -560 002, Proposal No: FP/KA/ROAD/143079/2021

With reference to the above, the Application was forwarded vide Ref(1) for approval to construct the 30.00Mtrs wide road along the Survey No: 52 & 53 of Panathur Village, Varthuru 2 Hobli, Survey No:109 of Gunjurpalya Village, Varthuru 1 Hobli, Bengaluru East Taluk, Bengaluru Urban District. As per the letter dated 16/06/2021 from your kind-self, some remarks were made to clarify from our end, as per the Reference item Part 1 , Item No : A-1(viii) “ Forest and Non-Forest Land requirement has been shown as 0.99 Ha and 9.61 Ha respectively. The Forest Land requirement cannot be verified as the Map Uploaded in item C(iv) Reveal that some portion (in between panathur Sy No:53) The forest area has not

been provided and it has been mentioned as another proposal will be submitted for formation of 45.00Mtrs RMP Road from ORR to PRR but the Road alignment for the present said road is abruptly cutting in the middle", has been made .

Since, the Formation of 45.00Mtrs wide Road from ORR to PRR has already been under progress, hence we have considered the entire stretch of 45.00Mtrs Wide road for approval including overlapping Portion of 45.00Mtrs on 30.00Mtrs wide road has been taken in the 45.00Mtrs Wide Road itself. The seperate application will be forwarded for the 45.00Mtrs wide Road and the overlapping portion will be included in the proposed application.

Hence, Approval may be given for the formation of 30.00Mtrs wide road for which the application is already submitted.
