Accordingly, the Sub-Divisional Committee of RoFR Act, 2006 under Chairmanship of Revenue Divisional Officer, Mulugu and members unanimously passed resolution that there is no objection of the diversion of forest land measuring an extent of 0.3504Ha in Bandala Reserve Forest of Tadvai Forest Division for Palair Segment Mission Bagheeradha in Mulugu District for laying of Pipeline and Structures under Telangana Drinking Water supply in favour of the Superintending Engineer Mission Bhagiratha Circle Warangal Rural as there is no encroachments by the tribal people in the proposed forest land to be diverted and further resolved that there are no pending RoFR claims to be settled under the Forest Rights Act.

Based on the resolutions passed Sub- Divisional Committee Mulug, the members of District Level Committee have no objection regarding diversion of Forest land measuring an extent of 0.3504Ha in Bandala Reserve Forest of Tadvai Forest Division for Palair Segment Mission Bagheeradha in Mulugu District in favour of the Superintending Engineer Mission Bhagiratha Circle Warangal Rural as there is no encroachments by the tribal people in the proposed forest land to be diverted and further resolved that there are no pending RoFR claims to be settled under the Forest Rights Act.
