With reference to your memo cited above, after due compliance of the discrepancies/ shortcomings as under the above proposal is resubmitted herewith in pentaplicate for necessary action at your end.

- 1- The check list enclosed in the proposal has been signed.
- 2- As per compliance of the user agency vide his letter No. 962 dt. 04.07.2017 (copy enclosed), stated that, initially the proposal was submitted for 33.337 ha. of Forest land in Angul District and 37.076 ha. of Forest land in Deogarh District and FRA certificate issued by the Collector Angul is 82.378 Ac. i.e. 33.337 ha and FRA certificate issued by the Collector, Deogarh is 14.9 ha. & 22.176 ha. total to 37.076 ha. Now the proposal is revised to 28.266 ha. in Angul District and 35.445 ha. in Deogarh District. The above Forest land proposed for diversion in both district is included in the FRA certificate issued earlier by the Collector, Angul and Collector, Deogarh respectively.
- 3- All abstract of tree enumeration list has been countersigned. Abstract of trees of page 167 has been revised by the User agency.
