Dear Sir,

Integrated Regional office/ Nagpur, Ministry of Environment, Forest & Climate Change of Govt. of India had placed the proposal before Regional Empowered Committee (REC) in its meeting held on 16.09.2021. The Committee, after detailed discussion and examination of the proposal, decided to call further notemarks/additional information and proposal to be resubmitted to the Committee for evaluation vide letter referred above.

In view of the above remarks on the observations pertaining to this office are as under: -

iii.	Since the User Agency in instant proposal is State Government the dispensation over raising CA over double degraded forest land is not applicable. iv.	There is possibility of proposing alignment further south of existing alignment specifically at the place where tunnel is proposed, accordingly the state Government shall explore possibility of shifting proposed alignment towards south of existing alignment.	The proposed alignment for the corridor has been kept on North of existing alignment keeping in view major constraints on south of existing alignment for the suburban corridor. Since the existing alignment is single line section and doubling of the same need to be done on south side only considering various constraints and technical & operational requirements of the section. Hence new corridor has been planned on north of existing alignment and detour near the tunnel location has been done on technical ground for the safety of existing tunnel.

In view of above, it is requested to send the detailed reply along with compliance for item no. (i) to Integrated Regional office, MOEF & CC, Nagpur for further consideration of the proposal for approval under the Forest (Conservation) Act 1980.
