Please refer to the State Government letter above on the subject mentioned above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. I am to inform that the proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder and proposal has been found deficient. The following additional information/documents are found lacking:

- (i) To provide Annexure I & II as mentioned in the submitted Forest Right Act, 2006 certificate.
- (ii) The undertaking for payment of Additional NPV by the user agency.
- (iii) The density of vegetation of the propose of the proposed site and its eco- class.
- (iv) The approved mine plan of the project, if applicable.
- (v) The shape/kml file of the proposed diversion area and compensatory afforestation site both in soft and hard copy.

Further, it is observed that the acknowledgement slip for uploading of the proposal as mentioned in the Ministry letter No 16-13/2011-FC dated 29.10.2013 and this office letter No. 2-1-51/2004/RONE/VOL III/3467-73 dated 12.11.2013 is not enclosed with the submitted proposal. Therefore, the proposal is hereby returned in original and State Govt is requested to kindly take necessary action for uploading the proposal in the Ministry's website as per Ministry's letter dated 29.10.2013 and submit the acknowledgement slip and the proposal along with the additional information mentioned above to the Regional Office at the earliest for further processing of the proposal.
