21 amount not exceeding Rs. 56,000,00/- (Fifty six lac Only) against any loss or damage caused to or
22 suffered or would be suffered by the principal, by reasons of any breach of the terms or conditions
23 contained in the said agreement.

24 We, ICICI Bank do hereby undertake to pay the amount due and payable under this guarantee
25 without any demur, merely on a demand from the principal stating that amount claimed is on
26 account of making good and executed trench for laying of underground cable of proper filling and
27 compaction, as to restore the land in the same condition as it was before digging the trench,
28 debris/loose earth produced due to execution of trenching. However our liability under this
29 guarantee shall be restricted to Rs. 56,000,00/- (Fifty six lac Only) We undertake to pay the principal
30 any money so demanded notwithstanding any dispute or disputes raised by the contractor(s) in
31 any suit or proceeding pending before any court or tribunal relating there our liability under this
32 present being absolute and unequivocal. The payment so made by us under this bond shall be a
33 valid discharge of our liability for payment there under and the contractor(s) shall have to claim
34 against us for making such payments.


