Sir,

This is with reference to the Minutes of the 8th meeting of Regional Empowered Committee held in the office of Integrated Regional Office, Shimla. We submit our comments point wise as under.

1. The issue of review of aerial distance from Nargu Wild Life Sanctuary has been confirmed by the DFO Wild Life Division Kullu. Copies of Letter No. C.I.II/1555 dated 06.06.2022 are enclosed, in triplicate, as Annexure "A".
2. This is to submit that transmission line is Double circuit line .
3. As per Revenue Record "Measurement Unit" is "KARAM". For taking 5 Karam on lease, it comes to 7.1 mtr all over the State as against FCA approved plan of 7 mtr . In this connection we submit that at the time of actual acquiring of land, we shall adjust the width to 7 mtr and give away the extra land. We are, however also taking up the issue with the State Government as well as Government of India MoEF&CC, separately.

4. The "KARAM" issue in width of transmission line in the extant proposal should be brought by Nodal Officer Shimla to the notice of MoEF&CC at the time of submission of proposal to MoEF&CC for appropriate decision at Ministry level by IRO, Shimla.
5. This is true that the proposal was originally submitted by Shri Bhup Raj but thereafter, the change of name from Bhup Raj to M/S Shivganga Hydel Power Project was done as per "Agreement of change of name" amongst the Special Secretary (NES), the Government of Himachal Pradesh-cum- DOE, Himurja, Shimla-171009, Shri Bhup Raj and M/S Shivganga Hydel Power Project on 29th September, 2021, copies enclosed, in triplicate as Annexure "B" for your kind information and necessary action.
6. Hard copies of the Layout Plan, in triplicate, showing all the Components in distinct colours duly counter signed by DFO Joginder Nagar are enclosed as Annexure 'C'.
7. We submit that there is no HEP in upstream/downstream of the landscape of our project on the Kalangher rivulet.
8. The details of the area (KML and Geo-referenced map) proposed for planting 1120 trees by way of CA will be uploaded in online portal Part II at Para 13 by DFO Joginder Nagar.
9. This issue has already been discussed/ replied at Point No. 1 above.
