I am directed to refer to your letter No.NHIDCL/H-HAWAI/Bo-Ita/2015-16/Vol-I/129 dated 23.11.2015 on the subject cited above subject seeking prior permission under the Forest (Conservation) Act, 1980 for change of User Agency from Border Road Task Force (BRTF) to National Highway Infrastructure Development Corporation Ltd.(NHIDCL).

In this connection, I am directed to say that the proposal was submitted to the MoEF&CC for according permission for change of User Agency. The MoEF&CC, after careful consideration of proposal, has authorized the State Govt. to accord permission for change of User Agency vide its letter F.No.11-186/2016-FC dated 7th September'2016.

On the basis of the recommendation of the Central Government and on fulfillment of all requisite conditions for transfer of lease, the State Govt. hereby grants approval for change of User Agency (transfer of lease) from BRTF to NHIDCL for diversion of 91.737 ha of forestland for improvement of Hayuliang-Hawai road from 0.00 km to 51.78 km in Anjaw District of Arunachal Pradesh subject to the condition that **no further change in the ownership** will be allowed and **all terms and conditions prescribed in earlier approval vide letter of even no. dated 09.09.2015** shall be strictly adhered to.


