Distric Level Committee meeting is held in the conference hall of D.L.C., Golaghat on 26/03/2012 regarding clearance of three nos. proposals for diversion of Forest land for drilling by O.N.G.C. placed by D.L.C., Golaghat.

Member Secretary D.L.C. placed three nos. of proposals No. 1 UHEAA (1.92 Hact.) and No. 2 UHEAA (0.75 Hact.) under Rengma R.F. and No. 3 KPAD (2.17 Hact.) under Doyang R.F. before the D.L.C. for clearance under FRA/06 for drilling purpose of O.N.G.C., before the D.L.C.

In discussion it is observed that all processes have maintained and those are found to be

adequate steps for developing a forest by planting saplings in its all Forest locations which have been diverted for non-forest use. The D.L.C. also suggested that all compensation including rehabilitation cost to be given by O.N.G.C. to the occupiers.

Based on the deliberation and submission of D.L.C., ~~Deputy Commissioner, Golaghat~~ approved the clearance of proposals of O.N.G.C. on the basis of the report of ~~Deputy Commissioner, Golaghat~~ for the necessary clearance certificate as per FRA-2006 subject to the final approval of the Environment & Forest, Govt. of India.


