Sir,

You are requested to please furnish 14 copies of jointly verified maps of the following non-forest Govt. plot indicating boundary descriptions (North, South, East & West) along with certifications of suitability for plantation and non-encumbrance etc. of each plots to facilitate preparation of the scheme for compensatory Afforestation.

The non-forest land be demarcated in the field by posting durable pillars of size 1.25m x 20cm x 20cm at all points along the boundary and conspicuous sign boards be fixed at the site to indicate that it is earmarked for compensatory afforestation in respect of the particular project. Further 4 ( Four) Hects Grids (plots) in the field by posting 10 Cm X 10 Cm X 20 Cm stone pillars which is embedded in soil which is 30 Cm billow and 20 Cm above the surface be made. Posting of boundary pillars and signboards to be done by the user agency
