However as per Forest (Conservation) Rules, 2016, The process for F.R.A. Certificate can be completed by the District Collector within the time stipulated for in-principle approval (copy enclosed). Further, MoEFCC vide guideline issued on 26.02.2019 has re-affirmed the fact that F.R.A Certificate is not mandatory for consideration of In-Principle Approval (copy enclosed).
