In inviting a kind reference to the letter and subject cited above, the point wise compliance to the observation raised by DFO, Bonai pertaining to construction of the proposed overhead conveyor belt form Barsuan Railway Siding to Kurmitar Iron Ore Mines of OMC is given as under for scrutiny and further processing onward:

**1. Observation No.1: The Land Schedule of PRF land should be signed by the User Agency and to be authenticated by the Range Officer, Barsuan and Tehsildar, Lahunipara in the following proforma:**

In compliance, it is submitted that the information as per the prescribed proforma is given in Annexure-I and authenticated by the Authorised signatory of OMC, Range Officer, Barsuan and Tehsildar, Lahunipara and enclosed herewith for kind perusal.

**5. Observation No.5: Certificates (NoC) from Collector, Sundargarh under the Forest Rights Act'2006 is to be furnished.**

In compliance, it is submitted that vide letter No.4199/OMC/F&E/2020 dt 16.03.2020, OMC has requested Collector, Sundargarh to issue the certificate under FRA, 2006 over 86.479 ha of forest land proposed for diversion. DFO, Bonai vide letter No.5769/6F-(Mg.) dt 25.06.2020 has also requested the Collector, Sundargarh to issue certificate under FRA, 2006 over 86.479 ha of entire forest land involved in the project to process the proposal. An undertaking by OMC to submit the certificate under FRA, 2006 before grant of stage-II Forest Clearance is enclosed at Annexure-II for kind consideration.

**6. Observation No.6: The Letter of technical approval of the Project should be enclosed.**

In compliance, it is submitted that Department of Steel & Mines vide letter No.1528/SM dt 01.03.2019 have been pleased to grant in-principle approval for engagement of a MDO for Kurmitar mines with an advice to finalise the tender conditions by OMC for installation of conveyor corridor and railway siding. Accordingly, the Board of Directors of OMC approved the technical aspects and finally OMC awarded the work in MDO mode. Department of Steel & Mines also issued a "No Objection Certificate" in favour of OMC vide letter No.5579/SM dt 30.06.2020. The copy of the letters is enclosed as Annexure-III series.

**7. Observation No.7: As per Letter No. R & DM-GE (GL)-S-63/13-4822/CS dt.12.02.2015 of the Chief Secretary of Odisha addressed to all Collectors, necessary Certificate should be furnished by the Tahasildar as regards status of total land involved in the project (both Forest & Non-forest) as per Govt. record as on 25.10.1980.**

In compliance, it is submitted that certificate as regards status of total land involved in the project (both Forest & Non-forest) as per Govt. record as on 25.10.1980 has been authenticated by the Range Officer, Barsuan and Tahasildar, Lahunipara and enclosed herewith as Annexure-I.

**8. Observation No.8: All the Check lists furnished in the diversion proposal to be duly filled in all columns and should be signed by the User Agency with date and place duly mentioned.**

In compliance, it is submitted that the Check lists furnished in the diversion proposal has been duly filled in all columns and also signed by OMC with date and place duly mentioned.

**9. Observation No.9: Since the project is a linear project, the concerned Check list duly filled in by the User Agency and to be attached to the DP.**

In compliance, it is submitted that the Check list for linear diversion has been duly filled in by OMC and attached to the DP.

**10. Observation No.10:** *All papers/pages should be signed by the Authorised Signatory of the User Agency.*

In compliance, it is submitted that all papers/pages has been signed by the Authorised Signatory, OMC.

**11. Observation No.11:** *The Page No.10 of Part-I is missing, the said page should be enclosed to the DP.*

In compliance, it is submitted that the Page No.10 has been placed in the DP.

**12. Observation No.12:** *The Length and width of proposed overhead conveyor belt in different categories of forest should be mentioned.*

In compliance, it is submitted that the length and breadth of the overhead conveyor in different categories of forest is given at Annexure-IV enclosed herewith.

**13. Observation No.13:** *The length and width of proposed overhead conveyor belt in non-forest area should be mentioned.*

In compliance, it is submitted that the length and breadth of the overhead conveyor in non- forest area is given at Annexure-IV enclosed herewith

**14. Observation No.14:** *The proposed overhead conveyor belt passes through Rantha ML and already diverted forest area for Infrastructure area for facilitating mining operation in Kurmitar & Rantha ML of M/s OMC Ltd., the length and width of the overhead conveyor belt in these structure should be mentioned separately.*

In compliance, it is submitted that the length and breadth of the overhead conveyor belt passing through Rantha ML of OMC and that of Infrastructure area for Kurmitar and Rantha is given separately at Annexure-IV enclosed herewith.

**15. Observation No.15:** *The Infrastructure project for facilitating mining operation in Kurmitar & Rantha ML of M/s OMC Ltd. has accorded final approval vide Letter No.5-ORC322/2017-BHU dt.29.5.2020 of the MoEF & CC, ERO, Bhubaneswar. But in the instant proposal it has mentioned the above project has got Stage-I clearance, this should be rectified accordingly in the present diversion proposal.*

In compliance, it is submitted that the observation has been well taken by making necessary correction in the diversion proposal.

**16. Observation No.16:** *The applied area should be delineated in the Topo Sheet signed by the User Agency and authenticated by the Range Officer, Barsuan, Tehsildar, Lahunipara and to be enclosed to the DP.*

In compliance, it is submitted that the area proposed for diversion has been delineated in the Topo Sheet signed by OMC and authenticated by the Range Officer, Barsuan, Tehsildar, Lahunipara. The Topo Map so signed is enclosed as Plate No.I to the DP.

**17. Observation No.17:** *The alternative Map (Plate-I) submitted in the DP should be authenticated by the Range Officer, Barsuan, Tehsildar, Lahunipara and to be enclosed to the DP.*

In compliance, it is submitted that the alternative Map (Plate-I) submitted in the DP has been authenticated by the Range Officer, Barsuan, Tehsildar, Lahunipara and enclosed to the DP and re-numbered as Plate No.II.

*18. Observation No.18: The Existing/ Present Land Use Plan not enclosed to the Diversion Proposal. The said Plan should be enclosed to the diversion proposal after authenticated from the Range Officer, Barsuan, and Tehsildar Lahunipara.*

In compliance, it is submitted that the Existing/Present Land Use Plan duly authenticated by the Range Officer, Barsuan and Tehsildar Lahunipara is enclosed to the Diversion Proposal as Plate No.III.

*19. Observation No.19: The proposed area passes through the already diverted forest area for Infrastructure project for facilitating mining operation in Kurmitar & Rantha ML of M/s OMC Ltd. should be shown in the Proposed Land Use Plan (Plate No.III) submitted with the DP and to be authenticated by the Range Officer, Barsuan and Tehsildar, Lahunipara and to be enclosed to the DP.*

In compliance, it is submitted that the Proposed Land Use Plan has been prepared, re-numbered as Plate No.IV and has been authenticated by the Range Officer, Barsuan and Tehsildar, Lahunipara and submitted with the DP.

*20. Observation No.20: Map of the applied diversion area should be shown in Revenue Sheet. The forest area and non-forest area should be shown in different colour, and it should be reflected in the Index in each map. The Revenue Maps should be signed by User Agency and authenticated by the Range Officer, Barsuan and Tehsildar, Lahunipara.*

In compliance, it is submitted that the map of the applied diversion area has been shown on the Revenue sheet with different colour code for forest and non-forest area. The map has been duly indexed and authenticated by Range Officer, Barsuan and Tehsildar, Lahunipara and submitted with the DP as Plate No.V.

*21. Observation No.21: The Layout plan not enclosed to the DP. The said Plan should be enclosed to the diversion proposal after authenticated from the Range Officer, Barsuan, and Tehsildar Lahunipara.*

In compliance, it is submitted that the Layout plan duly authenticated by the Range Officer, Barsuan, and Tehsildar Lahunipara is submitted with the DP at Plate No.I.

*22. Observation No.22: The Lease Profile as prescribed in Para-2.1 (2) of the guidelines issued under the F.C. Act'1980 should be enclosed to the diversion proposal.*

In compliance, it is submitted that the lease profile of OMC is enclosed to the DP as Annexure-XXIV series.

*23. Observation No.23: The proposed overhead conveyor belt passes through Rantha ML and already diverted forest area for Infrastructure project for facilitating mining operation in Kurmitar & Rantha ML of M/s OMC Ltd. The NoC from Rantha Mining Lease should be obtained and to be enclosed to the DP.*

*In the instant proposal, you have mentioned an area 1.304 ha. of forest land passes through already diverted forest area for Infrastructure project for facilitating mining operation in Kurmitar & Rantha ML of M/s OMC Ltd. and the above said area has already been diverted in favour of M/s OMC Ltd. and applied for re-diversion of the said area. Hence, it is requested to go through Para-5.6 of Chapter-5 of the Handbook of Forest (Conservation) Act'1980 and Forest Conservation Rules,2003 (Guidelines & Clarification) issued vide Letter No.5-2/2017-FC dt.28.3.2019 of the MoEF & CC and submit necessary documents/consent in this regards to the D.P.*

In compliance, it is submitted that OMC is the lessee for Rantha ML. Since the present proposal has been submitted by OMC, there is no objection from OMC side. NoC issued by the Authorised signatory of OMC for utilising part of Rantha ML for overhead conveyor is enclosed to the DP as Annexure-V.

Further, the details regarding primary approval accorded in favour of OMC and the new proposed use/land use as per Para 5.6 (Re-diversion) of the guidelines dt 28.03.2019 is given at page no.6 to 8 of the Part-I of the DP for kind perusal.

**24. Observation No.24: Plate Nos. should be assigned to all Maps.**

In compliance, it is submitted that maps have been re-assigned with plate nos. as per the contents submitted with the DP.

**25. Observation No.25: Total benefit to the project due to the diversion should be mentioned in Annexure-XVII/DP (Cost-Benefit Analysis).**

In compliance, it is submitted that the total benefit to the project has been mentioned in the revised Annexure-XVII submitted in the DP.

**26. Observation No.26: The Proposal should be serially page numbered with Annexure numbering.**
