

- (d) the discussion and decisions on such proposal had taken place only when there was a quorum of minimum 50% of the members of Gram Sabha present.
- (e) the diversion of forest land for facilities managed by the Government as required under section 3(2) of the FRA have been complete and the Gram Sabha have given their consent to it.
- (f) the rights of Primitive Tribes Groups and Pre-Agricultural Communities, where applicable have been specifically safeguard as per section 3(1)(e) of the FRA.
