The Reliance Jio Digital fibre Private Limited has reported that it has deposited an amount of Rs. 20,120/- towards the cost of Registration fees, & Processing Fee in the challan / bank receipt received vide letter dated 03/09/2020 of Reliance Jio Infocomm Limited. & as per letter of Add. Chief conservator of forest Land Reference No(5) Reliance Jio Digital fibre Private Limited has deposited an amount of Registration fee Rs 5000/- & Processing Fee Rs. 15,120/- in the account of 8782-Forest remittance (Deposit Head) on dt 03/09/2020.

The same has been confirmed by challan / bank receipt received vide letter dated 03/09/2020 of Reliance Jio Digital fibre Private Limited (Total amount of Received Registration fees Rs 5000/- & Processing Fee Rs. 15,120/-)

The undersigned is pleased to convey the formal approval of the Government under section 2 of the Forest (Conservation) Act, 1980, subject to the following conditions: -

1. The permission is granted only for use of the forest land for the purpose specified in the proposal. The legal status of the forest land shall remain unchanged.
2. The forest land shall not be used for any purpose other than that specified in the FCA proposal.
3. The User Agency will have to obtain permission from this office for carrying out any maintenance works in future.
4. The User Agency will have to make good the forest land after use/maintenance work. **No tree shall be cut.**
5. The User Agency will be liable to make good any loss to Forests/Environment caused to use of the said land by the user agency.
6. The User Agency will seek permission from the Roads & Buildings Department /National highway authority of india/ Science and Technology Department, Sachivalaya, Gandhinagar.
7. The Optical Fiber cables line will be laid underground in a trench of is not more than 2.00 mt depth and width of 0.45 mtr in between rows of road side plantation.
8. Any other condition, that the Ministry of Environment Forest & Climate Change may Stipulate from time to time in interest of conservation, protection and development of forest & Wildlife.
9. The user agency shall obtain FRA (Forest Right Act-2006) Certificate from Concerned District Collector's (Girsomnath & Junagadh) and submitting to this Forest Division.
10. User Agency shall obtain Environmental clearance as per the provision of the Environmental (Protection) Act, 1986, **if applicable.**
11. The Layout plan of the proposal shall not be changed without prior approval of Central Government.
12. No Labour Camp shall be established on the forest land.
13. The User Agency will be responsible for any loss to Forest/Environment caused Due to the use of the said land by the User Agency.

14. Violation of any of these conditions will amount to violation of Forest (Conservation) Act, 1980 and action would taken as per MoEF & CC Guideline F.No.11-42/2017-FC dt. 29/01/2018.
15. User agency shall upload this memorandum Letter with Compliance report in (<https://parivesh.nic.in/>) and inform to this office.
