Dear Sir,

With reference to above subject matter and letter under reference (copy enclosed as **Annexure I**), this is to submit that 378.935 Ha land has been diverted in favor of M/s Northern Coalfields Limited for mining of coal in Bina Opencast Project. Out of the above 378.935 Ha Forest Land., 7.623 Ha Forest Land is required to be transferred to the adjoining Khadia Opencast Project of the same company i.e., Northern Coalfields Limited.

As per the approved Mining Plan of the proposed EC expansion from coal production of 10.5 MTPA to 17.5 MTPA, land use plan of Bina Expansion OCP excludes above 7.623 Ha Forest Land to merge the same with the adjoining Khadia Opencast Project.

In view of the above, it is requested to kindly transfer the 7.623 Ha Forest Land from Bina Opencast Project to the adjoining Khadia Opencast Project of the same company i.e., Northern Coalfields Limited. Khadia Opencast Project has submitted an undertaking for transfer and compliance of conditions of FC of above 7.623 ha Forest Land, a copy of which is enclosed as **Annexure II**.

Further, it may be kindly noted that process of NPV and CA has already been completed for the entire 378.935 Ha Forest Land by Bina OCP, a copy of supporting documents is enclosed herewith as **Annexure III.** 

After excluding 7.623 Ha Forest Land from Bina OCP, revised land use plan of Bina OCP may be considered as per the approved Mining Plan of the proposed EC expansion from 10.5 MTPA to 17.5 MTPA vide MoEF&CC's proposal no. IA/UP/CMIN/428886/2023 dated 12/05/2023 (copy of EDS enclosed as **Annexure IV**).

In view of the above, it is requested to kindly consider the proposal for transfer of diverted 7.623 Ha Forest Land from Bina Opencast Project of M/s Northern Coalfields Limited to Khadia Opencast Project of Northern Coalfields Limited as well as change in land use plan of Bina Opencast Project.

Sir,

I am directed to refer to your letter No. F-1/368/05/10-11/1345 dated 31.05.2005 on the above mentioned subject, wherein the above proposal for diversion of 378.935 ha. of forest land for Bina Extension Open-Cast Mining project for coal in favour of M/S. Northern Coal Fights Limited in District Sidhi, Madhya Pradesh was submitted seeking prior approval of the Central Government in accordance with Section-2 of the Forest (Conservation) Act, 1980.

After careful consideration of the proposal of the State Government and on the basis of the recommendations of the Forest Advisory Committee, the Central Government granted inprinciple approval to the said proposal under Section-2 of the Forest (Conservation) Act, 1980, on 18.07.2006. The request of the User Agency, that the Condition No 1 of the order dated over double degraded forest land as is applicable to Central Government Public Undertaking, and a splaced before the Forest Advisory Committee in its meeting held on 27.09.2006. The Forest as follows:— "The Compensatory Afforestation shall be raised and maintained over the Agency."

3. A compliance report has been received from the Nodal Officer (FC), Madhya Pradesh, vide letter No. F-1/368/05/10-11/460 dated 21.02.2007. After considering the proposal and hereby grants approval, under the Forest (Conservation) Act, 1980, for diversion of 378.935 ha. Coal Fields Limited in District Sidhi, Madhya Pradesh, subject to fulfilment of following conditions:

1. Legal status of the forest land shall remain unchanged.

2. The Compensatory Afforestation shall be raised and maintained over degraded forest land double in extent to the area broken after 1980, by the User Agency at the Project Cost.

Maria

The State Government shall charge the Net Present Value of the forest area diverted under this proposal from the User Agency as per the orders of the Hon'ble Supreme Court of India dated 30.10.2002 and 01.08.2003 in IA No. 566 in WP (C) No. 202/1995 and as per the guidelines issued by this Ministry vide letters No. 5-1/1998-FC (Pt. II) dated 18.09.2003, as well as letter No. 5-2/2006-FC dated 03.10.2006 in this regard.

4. The State Government shall deposit NPV and all other funds with the Ad-hoc Body of Compensatory Afforestation Fund Management and Planning Authority (CAMPA) in Account No. CA 1579 of Corporation Bank, Block-11, Ground Floor, CGO Complex,

Phase-1, Lodhi Road, New Delhi-110003.

5. Additional amount of NPV of the diverted forest land, if any, becoming due after finalization of the same by the Hon'ble Supreme Court of India on receipt of the report from the Expert Committee, shall be charged by the State Government from the User Agency.

- 6. The User Agency shall create, fence and maintain a proper safety zone around the mining area. The User Agency shall deposit funds with the Forest Department for the creation, protection and regeneration of the safety zone area, and also shall bear the cost of afforestation over one and a half time of the safety zone area in degraded forest elsewhere.
- 7. Phased reclamation of the mine shall be carried out by the User Agency as per the approved Reclamation Plan at the Project Cost.

-8. Rehabilitation and resettlement of the displaced persons shall be carried out by the User

Agency as per the R & R plan submitted for the purpose.

9. Demarcation of the area shall be done on ground at the project cost using four feet high RCC pillars with serial numbers, forward and back bearings and distances from pillar to pillar.

10. Trees shall be felled only when it becomes necessary and that should be done under strict

supervision of the State Forest Department.

11. No labor camps shall be established on the forest land.

- 12. Sufficient sirewood shall be provided by the User Agency to the laborers at the project cost after purchase from the State Forest Department/Forest Development Corporation.
- 13. The forest land shall not be used for any purpose other than that specified in the proposal.
- 14. The User Agency shall ensure that there should be no damage to the wildlife in the area. 15. All other standard conditions stipulated for Mining Projects shall be complied with by the

User Agency.

The proposal is for increase in production capacity from 10.5 to 17.5 MTPA along with increase in mine lease area upto 2079.221 ha which also involves the transfer of 7.623 ha of forest area from existing mine to adjacent Khadia mine. Therefore, the mine lease area of existing Bina extention project is being reduced and further increasing for expansion. Therefore, as per extant rule of EIA Notification 2006 altering the mine area based on which EC was granted, attracts modification of EC dated 29.07.2022. PP is, therefore, advised to take first amendment of EC and later proposal of expansion of the same mine shall be considered on merits. The proposal is therefore not applicable for expansion.
