Sub: Construction of 6 Lane access controlled Highway from DND- Faridabad-Ballabhgarh Bypass Junction with Delhi-Vadodara Expressway KMP- Interchange (NH-148 NA) under Bharatmala Pariyojana (Lot-4/Package-1) in state of Delhi-Reg. Submission of Forest Proposal under Forest (Conservation) Act, 1980 for the diversion of 3.9 Ha of forest land for non- forest purpose under Forest Division Faridabad.

Sir.

It is to inform you that National Highways Authority of India (NHAI), under Ministry of Road Transport & Highways, Government of India has proposed the "Construction of 6 Lane access controlled Highway from DND-Faridabad-Ballabhgarh Bypass Junction with Delhi-Vadodara Expressway KMP-Interchange (NH-148 NA) under Bharatmala Pariyojana (Lot-4/Package-1) in state of Haryana."

In pursuance of the above, Corridor Management Unit – Mathura, NHAI at Faridabad is taking up above mentioned project in state of Haryana having a total length of 46.563 km and Proposed Right of Way (PROW) is varying in between 30 m to 70 m. Sufficient care has been taken during the design stage to avoid acquisition of forest areas located along the project road. The proposed project falis in notified protected forest areas and diversion of protected forest land is unavoidable.

The forest land as identified is included in this proposal for your kind consideration and recommendation for grant for the diversion of forest land for non- forest purpose. It is also stated that NHAI is willing to pay compensation for Compensatory Afforestation (CA) and Net Present Value (NPV) etc. as per the government regulations.

This is a time bound project and has a potential to contribute in the economic wellbeing of local people of the adjoining area. Therefore, it is requested to consider the proposal and recommend granting the permission for the diversion of forest land.
