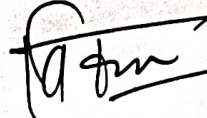

The arrangements for Treatment & disposal of the effluent from the Holiday Homes of the Central Railway at Mahabaleshwar as suggested by M.P.W.P. Board and constructed by you were inspected by me on 12.3.80 and found to be generally satisfactory and working of the holiday homes. may be allowed to be started.

Following rectifications, which you have promised to do, should be completed before 30.4.80.

- 1) Fixing 'V' notch properly so as to have 6" over fall on down stream side.
- 2) Absorption garden should be filled with Murum for an overall average depth of one meter.
- 3) Pipe lines with open joints or slotted holes should be provided in the Absorption Garden so as to have proper distribution of effluent in all parts of the garden.
- 4) Catch -drain along out side peripheri of the absorption garden should have minimum depth of 0.5. meter at all place
- 5) The septic tanks should be charged & seeded properly before putting into actual operation.

Apart from abiding by all the 15 conditions mentioned in conse letter No.80/KRI/32/1225 dt.28.2.79 of M.P.W.P. Board if shoul we noted that if at any time in furture it is observed that the effluent system is not working properly and its sub-surface obsorption is not proper, arrangement must be made at a short notice of 15 days to pump all effluent on the otherside of the ridge failing which permission to occupy -Holiday homes will be withdrawn.

A detailed report be made to this office after compliance of above points
