ORDER:

In the reference 3rd read above, the Engineer-in-Chief, RWS & S has submitted NABARD proposals, for 661 works with an amount of Rs.301.76 Crores for sanction under NABARD- RIDF Tranche – XXIV directly to the General Manager, NABARD, Hyderabad.

2. In the reference 4th read above, the Special Secretary to Government (B & IF), Finance (NABARD.SP) Department has stated that NABARD had sanctioned loan amount of Rs.23080.94 lakhs out of total project outlay of Rs.27154.05 Lakhs under Rural Infrastructure Development Fund – XXIV (2018-2019) for construction of 582 Rural Water Supply Projects and requested to issue administrative approval for the projects now sanctioned by the NABARD well before 10.09.2018 and furnish the same to NABARD under intimation to Finance (NABARD.SP) Department.

3. The Assistant General Manager, NABARD, AP Regional Office in his letter Ref No.NB.AP.RO.HYD/1539/RIDF-XXIV/174 PSC /2018-2019, dt.27.08.2018 has stated that the loan in principle has been sanctioned pending submission of administrative approval within one month of the receipt of the letter and mentioned the details of the projects as follows:

Government after careful examination of the proposals and keeping in view of the sanction order of the Assistant General Manager, AP Regional office, NABARD, Hyderabad Dt.27.08.2018 hereby accord administrative sanction to the Engineer-in-Chief, RWS &S, A.P, Vijayawada for 582 works in Andhra Pradesh, which are cleared by NABARD under NABARD-RIDF-XXIV for an amount of Rs.27154.05 Lakhs. Out of the total project cost of Rs.27154.05, NABARD loan component is Rs.23080.94 Lakhs and State Government's share is Rs.4073.11 Lakhs. List of works annexed I & II to this order.

5. The Engineer - in- Chief, RWS &S, A.P is requested to follow the guidelines of the NABARD scrupulously and utilize the funds as per prescribed financial rules. Soft copy of technically approved/ sanctioned estimates of the above schemes shall be conveyed to Government within a week's time after work being put to tender. The Technical sanctions to be accorded for scope of the scheme must fully confirm to the above administrative sanction.

6. For any change from sanctioned technical estimates during the execution the "agreement authority" shall approach the concerned "approving authority", in writing. The said "approving authority" shall convey consent or otherwise within two weeks else the proposal of the "agreement authority" shall be deemed to have been approved by the "approving authority". No changes shall be made on ground without following due procedure. In case of works less than Rs.10.00 lakh the next higher authority shall be the "approving authority" for changes, if any to be made in already sanctioned technical estimates only.

7. The Engineer - in- Chief, RWS&S, A.P while conveying the technical approval/sanction should ensure that necessary instructions shall be incorporated therein, to all the concerned Agreement Authorities to follow the sequential order i.e. head-to-tail approach scrupulously (i) in grounding works and (ii) while sanctioning payments.

8. The Engineer - in- Chief, RWS&S, Vijayawada, is requested to take necessary action accordingly.

9. This order does not require the concurrence of Finance Department keeping in view of the letter of the Finance Department, vide their Letter No.FIN26023/12/NABARD & SP /2018-2, DATED.30.08.2018.
