Sub: - Joint site inspection of the proposal for diversion of 82.6044 ha. of forest land for widening /improvement of Lalcherra-Kanchanpur Section (Package 2) of NH 44(A) to 2 Laning with paved shoulders under Dhalai, Unakoti & North Tripura.

Sir.

In reference to the subject cited above, I have decided to site visit on 06.08.2021 and accordingly conducted site inspection in presence of your staff, forest officials and staff of the revenue department. List of officials are enclosed. During my site inspection, I could found that in the North District a portion of alignment of .kml file and physical ground position does not tally. The disport area is from chainage 39,130 to 41,580 with involvement area around 0.69215 ha. The status of land is CS Plot No.1477 & 1481, Khatian No.2-53, status of land is-RF and the mouja-Ujjan Machmara RF.

As per my assessment some more forest land may be involved /required from the CS Plot No.1477 as per GO Reference map.

In this regard I would like to inform you that please clarify whether you would like to continue this proposal with condition to initiate additional proposal seeking further requirement of forest land for the above mentioned issue. Time allow for confirmation is 02 (two) days on received of this letter.

The issue should be given topmost priority as till the clarification on the issue Part-III will not be processed from Conservator of Forests.
