	EDS dated: 04.07.2017 FP/UK/ROAD/10625/2015 Construction Gaithana-Sirwari Motor road under State Sector (3.1325ha) The reply of this office EDS dated 16.06.2016 has been submitted by the Addl. PCCF & Nodal Officer vide letter uploaded on 02.06.2017. Following shortcomings still remain in the reply/proposal:-	
l	Although, the geo referenced digital maps of the forest land proposed for diversion and the land proposed for CA have been uploaded at designated places in online Part-I but the original hard copies have not been submitted for placing in the hard copy of the proposal.	Original Hard copy had been submitted. Submitted letter attached. (Annexure1)
2	It is seen from the KML file that this proposed road does not appear to benefit the Gaithana & Sirwari villages because these villages already appear to be located near the existing roads. However, one human habitation located towards southern half of the proposed road appears to be benefited by this road. But, this habitation is close to one existing road near Sirwari & the construction of road from Sirwari end will involve less forest land. State Govt. may explore this feasibility.	Justification uploaded at other document. (Annexure2)
3	It is also seen from KML file of the road that approx. 126 m length of proposed road is passing through the area selected for CA involving approx. 0.09 ha land. This situation is bound to reduce the net area available for CA. State Govt. may either increase the CA area proportionately or change the CA site and submit necessary revised documents.	Proposed CA area is near proposed road area thus may be seen overlapping with road area which is net actual case.
4	Density is mentioned as 0.3 in para-4 of online Part-II and 0.001 in the old format of Part-II attached in hard copy of the proposal but NPV rate is charged for dense forest category in Eco-class-V. This mismatch in density in different documents and NPV rate is required to be reviewed	This EDS is related to DFO

mentioned in the FRA certificate that the forest land VLC proceeding for Sirwara and roposed for diversion falls within the jurisdiction of Gaithana, Bhelunta had been uploaded at Sirwari and Bhelunta villages but the proceedings of VLC other document and meeting has been provided for Gaithana village only. Hence, the certificate at K (i) (a) proceedings of VLC meeting of Sirwari and Bhelunta is also required to be submitted... Hard copy of the proposal contains photocopies of the Hard copy containing original documents. Hence, State Govt. submit hard copy of the proposal document had been sent. Letter containing original or attested copies of the documents except attached (Annexure1) the documents like FRA certificate, geo-referenced digital maps, maps in SoI toposheet, enumeration list, CA scheme and CA site suitability certificate which are required in original copies. State Govt. is requested to remove above shortcomings and submit revised information/documents/clarifications
