With reference to our letter no. 1164 dt. 09.08.2017, this is to inform that the necessary modification has already been undertaken from this end in the Forest Diversion Proposal as desired and submitted in 6 set hard copies to you.

The total forest land has been revised to 64.094 ha & all supporting documents w.r.t Unclassed forest category with justification has been submitted vide reference (3) above. The detail justifications for the difference in non-forest land has been furnished vide this office letter no. 1169 dt. 10.08.2017. The modification in CA scheme against 64.094 ha has already been processed with DFO, Keonjhar vide this office letter no. 1170 dt. 10.08.2017 & it is certified that necessary CA scheme will be modified & re-submitted to RCCF, Rourkela from this end very soon. Our representatives has already been deputed at your office for further assistance & support in this regard for processing of diversion proposal to RCCF, Rourkela. The Competent Authority of NHAI is pressing very hard to get stage-I approval at the earliest as Concessionaire has been fully mobilized at site & ready to commence the work on getting forest clearance
