

Kindly find enclosed here the reply to the observations raised by Nodal office Shimla as follows in favor of Solid Waste Management Plant in Dharamshala Distt. Kangra HP.

Sr. No.	OBSERVATIONS	REPLY
1	That the reply submitted by you earlier on dated 03-06-2023 have been denied by the Nodal Officer that there is violation of FCA 1980 so you are requested to submit the names of the persons responsible for violation to this office at the earliest so that further action could be taken in this matter.	That initially the project has been started in 1977 and regarding this evidences are enclosed herewith. As such no person is responsible for violation as the work has been done before the inception of FCA 1980. If the Forest Department considers it a violation then it is not possible to identify the violators because the incident then MC before 47 years ago. We have submitted that the possession over this land has been with MC since the year 1977, and continuous till now. The proposal is being submitted for diversion of 2.9696 hect. of forest land as per Hon'able NGT Court orders dated 29-03-2019(copy enclosed) wherein it is mentioned that there is need to set up Municipal Solid waste processing plant. In the earlier reply the record till 1996 was submitted regarding use of this land. As such the Dharamshala Municipal corporation is very old and it was established as Council in the year of 1867. The record of the year 1977 regarding possession was found after great difficulty and has already been submitted along with Geo tagged photographs. The copy of the proceeding of general house of the Municipal Council, Certificate regarding possession and Geo tagged Photographs have been uploaded in portal on dated 26.06.2023. Keeping in the mind the interests and problems of the local people the Forest department may consider this proposal in favor of user agency on merits.

So therefore you are requested to kindly consider the proposal for further process and approval in favor of Solid waste management Plan Dharamshala.

2. Vide order dated 02.01.2019, the Municipal Corp. Dharamshala and Himachal Pradesh State Pollution Control Board (State PCB) were required to furnish an action taken report in the matter. Such a report has been filed on 05.02.2019 by the State PCB stating that the matter was taken up with the Urban Development Department, Himachal Pradesh and an inspection was carried out. There is need to set up a municipal solid waste processing plant adopting cluster approach for which tenders are being prepared by the Urban Development Department. Process of covering the debris with soil in a scientific way has also started, apart from

processing of bio-degradable waste and segregation and recycling of other waste. The Urban Development Department is taking further steps in the matter to set up integrated solid waste management plant at Kangra on PPP model. Steps will also be taken for management of bio-degradable and non bio-degradable waste.

3. We find that no timeline has been indicated in the reply filed by the State PCB with requisite budgetary provision. This aspect needs to be finalised by the Urban Development Department and monitored by the Chief Secretary, Himachal Pradesh, in terms of the directions of this Tribunal in Original Application No. 606 of 2018 vide order dated 05.03.2019. The State level Monitoring Committee constituted by this Tribunal vide order dated 16.01.2019 in Original Application No. 606 of 2018 may also monitor the situation with regard to fixing of timeline and budgetary provision.

The application stand disposed of.

ORDER

Allegation in this letter, which has been treated as an application, is that there is illegal dumping of garbage in village Sudher near Himachal Road Transport Corporation (HRTC) workshop affecting public health which is contrary to the Solid Waste Management Rules, 2016. No action is being taken by the Municipal Corporation, Dharamshala, Himachal Pradesh.

The applicant has also annexed letter of the HRTC, Dharamshala Division dated 26.06.2018 addressed to the Commissioner, Municipal Corporation, Dharamshala, letter of the Himachal Pradesh State Electricity Board Limited dated 02.07.2016 addressed to the Commissioner, Municipal Corporation, Dharamshala and letter of the Himachal Pradesh State Forest Development Corporation Limited, Directorate (North) Dharamshala dated 29.08.2018 addressed to the Commissioner, Municipal Corporation, Dharamshala to the same effect.

Let the Municipal Corporation, Dharamshala and the Himachal Pradesh State Pollution Control Board (HPSPCB) jointly look into the

matter and furnish an action taken report on factual aspects of the matter to this Tribunal within one month from the date of receipt of copy of this order by e-mail at ngt.filing@gmail.com.

The nodal agency will be the HPSPCB to coordinate and comply with the order.

Copy of this order along with complaint be sent to the HPSPCB for compliance by e-mail.

Needless to say that order of National Green Tribunal is binding as a decree of Court and non-compliance is actionable by way of punitive action including prosecution, in terms of the National Green Tribunal Act, 2010.




