Dear Sir,

This is to kindly bring to your notice that the proposal for forest land diversion of 126.72 ha forest land in respect of KDH OCP (Proposal no FP/JH/MIN/8374/2014 dated 05/12/2014) was forwarded by GoJ to MoEF&CC, New Delhi vide letter Van bhoomi-06/2017-1201 dated 22.04.2022.

The proposal was placed before Forest Advisory Committee on 13.06.2022. However, MoEF&CC has raised queries on three points vide letter File No. 8-62/2018-FC dated 22.06.2022.

The point wise reply to the queries is as under:

1	The State Government, after scrutiny of the relevant provisions of laws, will ascertain and inform the applicability of Forest (Conservation) Act, 1980 on the forestland acquired under CBA Act 1957, which has already been broken and still under the possession of the user agency i.e. still constituting the part of the project of the user agency	forest land (which means forest land broken prior 25.10.1980) within a coal mine project in the case of coal mines in/over an area vested in a Government Company under the Coal Bearing Area (Acquisition and Development) Act 1957.		
2	The IRO, Ranchi will carry out an indepth examination of the issues related to unauthorized use of forestland allowed by the DFO concerned citing the justification of controlling the raging fires in the mining lease of user agency and a report on the same supported with documentary evidences shall be submitted to the Ministry. IRO will coordinate with the concerned authorities			

	in the State for carrying out an in-depth examination of the matter		
3	The State Government will re-visit the suitability of CA land especially in view of encroachment reported over an area of 6.03 acres.	It is clarified that the area of 6.03 acres in not for the proposed CA land but falls under the area for which mining activity is proposed. This area is a part of 42.37 ha (104.69 acres) <i>Jangal Jhari</i> land under the jurisdiction of Revenue Department and is a part of proposal of diversion of a total of 126.72 ha of forest land.	
		As per the report of Circle Officer, Ranchi vide letter no. 48(ii) dated 21.01.2022 (Annexure-1), the 98.66 acre GMJJ land is free from encroachment and the encroachment has been found on only 6.03 acre GMJJ land. However, no claim under FRA, 2006 is pending on this part of land and the consent of Gram Sabha has also been obtained.	
		Once the approval of diversion of the said proposal including the aforementioned <i>Jungle Jhari</i> land is provided, the said encroachment will be cleared with the help of district administration and applicability of R&R policy of Coal India Limited.
