In online Part-II, details of only 94 number of trees has been given in respect of Dharamshala Forest Division whereas in proposal folder, from Page No. 226 to 242, details of 453 (94+210+149) number of trees has been given.	Pertains to Divisional Forest Office, Dharamshala
7.	Details of CA against column No. 10 of Part-II of Dharamshala Forest Division has not been given. Page number should clearly be given where the concern document/certificate is placed in the proposal folder.	Pertains to Divisional Forest Office, Dharamshala
8.	The date of progress of CA in respect of Hamirpur Forest Division has been shown as 07.03.2022 in Part-II of the proposal folder whereas in online Part-I, the date of progress of CA in respect of Hamirpur Forest Division has been mentioned as 23.06.2022.	Pertains to Divisional Forest Office, Hamirpur
9.	Number of trees in respect of Dehra Forest Division is not matching in online Part-II and enumeration list as placed in the proposal folder at P.No. 186 to 225	Pertains to Divisional Forest Office, Dehra
10.	Against column No. C (ii) & (iv) of online Part-I, digital maps and toposheets of the forest land proposed for diversion in respect of all three different forest divisions i.e. Hamirpur, Dehra & Dharamshala have not been found uploaded. It may be ensure that digital map and toposheet for three divisions have been uploaded against these column.	The said DGPS maps and Toposheets of all the three divisions have been again uploaded in the portal.
