As per the Principal Chief Conservator of Forests (HoFF), Chennai reference No.TS4/9178/22, dated 30.05.2022, the District Forest Officer, Karur Division has stated that an area of 0.874 hec. in Marudhur RF of Padugai Range in Pudukkottai Region under the control of TAFCORN is required for providing drinking water pipe lines and water tank from Cauver river to Sivagangai District, by the TWAD Board, Kulithalai.

Hence, the District Forest Officer, Karur has sent proposal for transfer back above said land to the TWAD Board, Kulithalai through Forest Department.

On receipt of proposal from District Forest Officer, Karur, the Regional Manager Pudukkottai has submitted his report for the loss sustained to the Corporation and the yield of full crop as per yield estimation is worked out and furnished here under.
