In compliance of the Rule 6(3)(e) of the Forest (Conservation) Rules,2003 [as amended vide the Forest (Conservation) Amendment Rules 2014; Forest (Conservation) second Amendment Rules 2014; and Forest (Conservation) Amendment Rules 2016] it is certify that **60.06 hectares** of forest land has been proposed to be diverted in favour of the Project Director, PIU, Visakhapatnam, Ministry of Road Transport & Highways (User agency) for laying of road under Green National Highway Corridor Project in Visakhapatnam district falls within the Jurisdiction of Package 1 - Koyyuru to Chaparathipalem (Km. 120+000 to Km. 165+500) section, Package 2 - Chaparathipalem to Lammasingi (Km. 165+500 to Km. 205+000) section and Package 3 - Lammasingi to Paderu (205+000 to 253+974).

It is further certified that:

- a. The complete recognition and vesting of Forest rights under the Forest Rights Act has been carried out for the above entire stretch of NH516E. Out of the above, no ROFR pattas have been issued pertaining to the stretches covered in G.Madugula (from Pedakiltaru to Bandaveedhi R.F) and Koyyuru Mandals (from Chinthalapudi to Katragedda R.F).
- b. Regarding G.K.Veedhi Mandal, there is an extent of 9.99ha is being effected RF land in proposed NH516E. Out of the above, there are 22 individual have been effected to an extent of 1.23ha from their RoFR patta land (partly) in Rampula Village, and 26 individuals have been effected to an extent of 1.02ha in Chaparathipalem Village of Pedavalasa Gram Panchayat of GK Veedhi Mandal.
- c. Regarding Chinthapalli Mandal, there is an extent of 9.38 ha is being effected RF land in proposed NH516E. Out of the above, there are 20 individual have been effected to an extent of 0.09 ha from their RoFR patta land (partly) in Kolapari Village of Komangi Gram Panchayat and 3 individuals have been effected to an extent of 0.05 ha in Chinthaluru Village of Pedavalasa Gram Panchayat of Chinthapalli Mandal.
- d. The diversion of Forest Lands for facilities managed by the Government as required under Section 3(2) of the FRA, 2006 have been explained and the Grama Sabhas, and have given their consent through resolutions.
- e. The proposed area does not involve recognized rights of Primitive Tribal Groups (PTGs) and Pre-Agricultural Communities.
- f. Compensation shall be provided along with the R&R Scheme as per the provisions in Section 41,42 & Sl.No.1 of Scheduled 2 of RFCT LA R&R Act., 30 of 2013 r/w rule 24&28 APRFCT LA R&R Rules, 2014.
