

Sir,

The Government of India through National Highways & Infrastructure Development Corporation Limited (NHIDCL) have decided to undertaken improvement of Imphal-Moreh road section of NH-39 (new AH-02) under Asian Development Bank (ADB) funded South Asia Subregional Economic Corridor (SASEC) Investment Program. The scope of this project includes improvement of Imphal-Moreh Road section to 4 lane /2 lane standard (main alignment) and a 2 lane alternate alignment from Wanjing to Khudemthabi

NHIDCL is submitting project details for Forest Clearance for Imphal-Moreh Road section of NH-39 to 2 lane with paved shoulder standard from Khongkhang to Moreh (29.516km) and improvement of alternate alignment of Imphal-Moreh road section on NH-39 to 2 lane with paved shoulder standard from Sita to Khudhengthabi (24.340 km) in district Chandel. In this regard, prior approval of the project under section 2 of Forest(Conservation) Act, 1930 by the Central Government a certificate in FORM-I (for Linear Project) of Annexure-I prescribed vide letter F. No. 11-9/98-FC (Pt) dated 05-02-2013 of the Ministry of Environment and Forest (Copy enclosed) to be issued by concerned Deputy Commissioner is mandatory. As per information published by the Ministry of Tribal Affairs, Government of India, there is only Marram Naga group of Primitive Tribal Group (PTG) namely, Marram Naga (Copy Enclosed). Under the circumstances, obtaining of consent of the concerned Gram Sabhas as stipulated may not be required as per office circular of Ministry of Environment and Forests, Government of India, referred above.

This project under Asian Development Bank (ADB) funded South Asia Subregional Economic Corridor (SASEC) Investment Program is a time bound project. It is therefore requested that the issue of the certificate in FORM-I (for Linear Project) of Annexure-I be kindly expedited to ensure timely start of the project.
