Subject:- Application for No objection Certificate (NOC) for establishment of Retail Outlet (Petrol Pump) at proposed location village Budhakhera on MDR-112, Block-Uklana Distt. Hisar, Haryana

Ref.: - Your office memo No. 1113-24/PL Dated 24.07.2020

The NOC case received from your office vide letter under reference is sent herewith that this office has no objection, as decided in the meeting held on dated 26.07.2021 under the chairmanship of the Superintending Engineer Hisar Circle PWD B&R Hisar. The NOC case was sent to Head office to grant relaxation in norms as Acceleration lane/ Deceleration lane is 3.96 mtr wide at site, whereas, it is required 5.50 mtr Metalled width + 2.25 Mtr shoulder = 7.75 Mtr. as per guideline issued by Head Office vide his memo No. 152824-152878/2020 dated 13.10.2020. Further the case was sent to State Govt. Haryana for relaxation in guideline and same has been approved after granting relaxation in policy/guidelines and received from the Head office vide memo No. 124866/RII Dt. 22.07.2021 (Copy attached). Accordingly the committee has decided to issue the NOC vide his memo No. 5756-58 dt. 06.08.2021.

1. That the construction work should be taken in hand/ started after taking Nishandehi from the Revenue Deptt. and there should be no encroachment on the PWD land which is recorded in the Revenue Deptt.
2. The Drawings submitted by the applicant will be strictly followed.
3. If any encroachment found on PWD land after construction, construction will be removed with his own cost.
4. There should be no hindrance of any kind to traffic, due to installation of sign board etc;
5. No material will be dumped on PWD land during construction work of Retail Outlet.

6. As per instruction issued by the department & IRC 12-2009, Rs. 0.60 lacs one time fee has been deposited by the retail outlet owner being MDR as lease charges for 15 years vide Demand Draft bearing No. 001333 dt. 09.08.2021.
7. The oil company/ Retail outlet owner will be bound to follow the instructions of PWD B&R Deptt. and IRC.2009 as well as instruction issued by the department time to time.
8. There is no Retail outlet exist with in 300 mtr. from the propose site.
9. That if the licensee/licensees fails to execute any work which they have agreed under this agreement to the full satisfaction of the Executive Engineer/Sub Divisional Engineer incharge the work shall be executed by the Executive Engineer/Sub Divisional Engineer incharge at the cost of licensee/licensees, and the expenditure incurred shall be recoverable from the licensee/licensees as an arrear of land revenue without prejudice to any other remedies which may be open to Govt. in this behalf.
10. That the licensee/licensees shall not, without the prior permission in writing of the Executive Engineer/Sub Divisional Engineer in charge in any way extend or alter the said approach road or any culvert or drains therein.

The clarifications/ information as desired vide your letter quoted under reference Sr. No. A to G does not relates to this with department.
