Government of Gujarat, Forest & Environment Department, Gandhinagar vide its circular mentioned under Reference has delegated powers under "General Approval" to the concerned divisional forests officer to grant approval under forest (Conservation) act. 1980 for laying of underground optical fiber cables, telephone lines, drinking water, electric lines, CNG/PNG pipeline and Petroleum pipeline along the roads within existing right of way not falling in National Parks and Wildlife sanctuaries, without felling of trees, where the maximum size of the trench is not more, than 2.00 meter depth and 1.00 meter width subject to certain conditions.

AND whereas the user agency while applying and through the documents submitted has confirmed that its FCA proposal falls along the roads within existing right of way not falling in National Parks and Wildlife sanctuaries without felling of trees, where the maximum size of the trench is not more than 2.00 meter depth and 1.00 meter width and hence fulfils all the above specified conditions and eligibility, as laid down in circular mentioned at ref (1) and falls

AND whereas having verified on the site that above facts are correct and fulfils the above specific conditions of "general approval" the following order is issued.

In view of the above the undersigned is pleased to convey its "in principle" approval for diversion of 0.080 Ha. Of Protected Forest Land in Bhavnagar District (Botad S.F.Division) subject to the following conditions:
