Sir,

With reference to the letter and subject cited above, I am to say that basing on the requisition filed by the Deputy General Manager (Geo) F&E, OMC, Ltd, Bhubaneswar you have been asked to conduct the joint inquiry of the land of Ac.14.98 equivalent to 6.064 hectare of non-forest Government land in village Mundighati. In the meantime the OMC Ltd. Bhubaneswar has filed revised requisition for allotment of Ac.18.577 or 7.518 hectare instead of Ac.14.98 or 6.064 hectare of non-forest Government land in village Mundighati under Th.Rampur Tahasil for raising compensatory afforestation on account of diversion of forest land pertaining to proposed road for evacuation of mineral from Gandhamardan (Block-A&B) Mines of OMC located in Keonjhar district.

In order to ascertain whether the proposed land is free from encroachment land encumbrances and suitable for plantation, you are requested to issue necessary instruction to the concerned Range Officer to make joint field verification along with Tahasildar, Th. Rampur in respect of the land schedule enclosed herewith. The joint verification report may please be furnished to this office early for further action.
