Consequent to the payment made by you towards restoration charges of amount Rs. 211,78,531/- (FDR No. 700751 dt: 31.03.2021) and Rs. 21,17,853/- towards permission fee (DD No. 345090 Dated: 30.03.2021) to this office. Permission accorded for laying the 1.60m dia MS water pipeline at Aadhi pampa layout to Chikkanayakanahalli muneshwara layout in Bangalor East Taluk subject to the following terms and conditions :

1. The Proposed water Pipe line is to be laid along the drain leaving 1.00 m gap from Concrete Open Trench method. If any damages to the asphalt / Concrete road the damaged cost should be borne by the BWSSB.
2. The excavation should be done as per the drawing given by you ,
3. After the excavation the Trench, the Trench shall be made good to its original condition using appropriate materials as per the MORTH/BSI specification, under the supervision of concerned PWD Engineer.

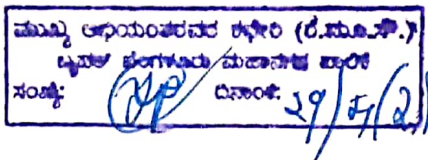

With reference to the above subject & in continuation of the letter vide above reference, we would like to inform you that this office is executing the water pipeline works for the City Trunk Main along the Eastern Route (CP-09 Package) under the BWSSB Phase III, Stage V Cauvery Project's to provide Water Supply facilities to the newly added area's (ie 110 Villages) under BBMP.

The proposed water pipeline alignment starts from Vajarahalli Junction upto the proposed Kadugodi Ground Level Reservoir for a total length of 53.50 Km.

The CP-09 package "City Trunk Main along the Eastern Route" is awarded to the contractor M/s L&T Ltd., & consists of laying MS pipeline trunk main ranging from 2.20m to 0.8m dia starting from Vajarahalli Junction to Kadugodi GLR along Balaji Layout, Holiday Village Road, Anjanapura BDA Layout, Gottiger, Bannerghatta Road (BBMP), C.K. Palya Road, Beggur Koppa Road, Bettadasanapura, Vittasandra Main Road, Basapura Main Road, Hosur Road crossing, Hosa Road, Aadhi Pampa Road, Muneshwara Layout, Kodathi Village Road, Sarjapura Road crossing, Mullur Village Road, Kachamaranahalli Village Road, Gunjur Club Road, Gunjur Palya Road, Proposed CDP Road, Thuburahalli Extension Road,



HAL Road, Nallurhalli Main Road, Pattandur Agrahara Road, ECC Road ITPL Road & branching line from Nallurhalli Road towards Hoodi GLR via I-Gate Junction road.

It is brought to your kind notice that there is provision for **road restoration** in the BWSSB CP-09 project and after the completion of the laying work the road will be restored as per the approved drawing enclosed which is as per the MORTH standard specification.


The proposed pipeline alignment was uploaded in the MARCS for road cutting permission to be issued by BBMP. However for the road cutting permission to our proposals with Request #16116, #16993 & #16969, the report generated on 27/04/2021 shows that demand note for road restoration amounting to Rs. 16,82,73,379/-, Rs. 2,06,43,447/- & Rs. 6,21,51,876/- respectively is raised by the BBMP division office.

In view of the above, since the **road restoration work** is included in our project and will be restored as per the approved construction drawing enclosed after the completion of the work, it is herewith requested to direct the concerned authorities to accord permission without considering the demand note for road restoration.
