**Sub:** Submission of Forest Proposal under Forest (Conservation) Act, 1980 for the diversion of forest land for non- forest purpose for the project "Development of Package-17 (Km 515+000 to Km 566+475) of Phase-II of Delhi Katra Expressway"-Reg.

Sir,

The proposed project pertains to Development of Package-17 (Km 515+000 to Km 566+475) of Phase-II of Delhi-Katra Expressway. The project starts at Km. 515+000 at Kunjwani Chowk of Jammu District and ends at Km 566+475 at village Parthal of Katra Tehsil in Reasi District in the UT of J&K. The proposed project will improve overall connectivity from Delhi to Katra. The development will also improve the connectivity between the UT of Jammu and Kashmir with the major cities of Punjab State, Haryana State and the National Capital Territory of Delhi.

The proposed project shall affect the local communities positively as it shall create a new shortest alternate route from Delhi to Katra as compared to current connectivity which is long and carrying the heavy traffic.

In pursuance of the above, National Highways Authority of India, PIU-Jammu has been appointed as Project Implementation Unit for the proposed development.

The total length of the proposed project alignment is 51.475 Km. The Forest Land identified in concerned forest division is included in this proposal for your kind consideration and recommendation for grant of the diversion of Forest land for non- forest purpose. It is pertinent to mention that we are willing to pay the amount towards Compensatory Afforestation (CA) and Net Present value (NPV) etc. as per the government regulations.

This is a time bound project and has a potential to contribute in the economic wellbeing of local people of the adjoining area. Therefore, we kindly request you to consider the proposal and recommend granting the permission for the diversion of forest land.
